Provides for setting aside prosecution and dismissal of certain cases upon successful completion of drug court probation

The proposed legislation provides that when a defendant has successfully completed all of the conditions of his probation set forth by a drug court probation program, his prosecution may be dismissed and have the effect of an acquittal, except in any subsequent prosecution of the defendant as a multiple offender as it relates to any other law or laws relating to cumulation of offenses.

The provisions of the proposed law are remedial and are to be applied retroactively.
