Requires certain school boards to provide information to certain students relative to human papillomavirus (HPV) and immunization against it

Proposed law requires city, parish, and other local public school boards that provide information about immunizations to provide to the parent or legal guardian of a student in grades 6-12 information about the risks associated with human papillomavirus (HPV) and the availability, effectiveness, and known contraindications of immunization against it. The legislation requires that such information include a form on which a student's parent or legal guardian may grant written permission for the student to receive such information directly. The Department of Health and Hospitals (DHH), and the Department of Education (DOE), are required to establish rules and regulations for carrying out proposed law in accordance with the APA. Nothing in proposed law shall be construed to require any city, parish, or other local public school board, DOE, or DHH to provide or pay for HIV immunizations or to require any person to be immunized against HPV.

EXPENDITURE EXPLANATION

The Department of Education states the cost for printing and postage of materials to be sent to the school boards is approximately \$100. Local fund expenditures will increase to provide parents information about the risks of human papillomavirus (HPV). According to October 1, 2007 student enrollment figures from the Department of Education, there are approximately 337,000 students in grades 6 through 12. If all school boards were to mail such information, the cost could be approximately \$130,000 for the postage if bulk mail is not used. There will be additional costs for printing materials. However, a school system may choose to send the information home with the students to give to the parents or mail the documents along with other materials sent to parents at the beginning of the year, which will reduce expenditures significantly.

The Department of Health and Hospitals states there will be no fiscal impact, unless they are required to print or purchase educational materials; however, the existing staff of the Sexually Transmitted Disease Control Program would be able to provide the required information.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
