2 Delete House Committee Amendments Nos. 9, 10, and 11 proposed by the House  
3 Committee on Health and Welfare and adopted by the House of Representatives on June 2,  
4 2008.

5 AMENDMENT NO. 2

6 On page 2, line 4, between "Section" and "shall" insert "**and is not exempted from**  
7 **compliance with Paragraph (1) of Subsection B of this Section**"

8 AMENDMENT NO. 3

9 On page 2, line 16, after "system" delete the remainder of the line in its entirety

10 AMENDMENT NO. 4

11 On page 2, delete lines 17 through 19 in their entirety

12 AMENDMENT NO. 5

13 On page 2, at the beginning of line 20, delete "citizenry"

14 AMENDMENT NO. 6

15 On page 2, line 21, between "provided" and "of" delete "all" and insert in lieu thereof  
16 "either"

17 AMENDMENT NO. 7

18 On page 2, between lines 21 and 22, insert the following:

19 **"(a) The members of the governing authority of each municipality and**  
20 **parish in whose jurisdiction the water system provides service has, by**  
21 **majority vote, approved the exemption, provided that a public hearing**  
22 **has been conducted by the governing authority of each municipality and**  
23 **parish and notice has been given to the Department of Health and**  
24 **Hospitals and the Fluoridation Advisory Board regarding the hearing.**  
25 **(b) A local election has been called on the exemption by each governing**  
26 **authority in whose jurisdiction the water system provides service in**  
27 **accordance with the following provisions:"**

29 On page 2, at the beginning of line 22, delete "(a) A" and insert "**(i) Prior to a local**  
30 **election being called, a**"

1 AMENDMENT NO. 9

2 On page 2, line 23, between "**voters**" and "**served**" delete "**in all municipalities**" and insert  
3 in lieu thereof "**who reside in the precincts**"

4 AMENDMENT NO. 10

5 On page 2, line 25, between "**governing**" and "**of**" delete "**body**" and insert in lieu thereof  
6 "**authority**" and between "**municipality**" and "**in**" insert in lieu thereof "**or parish**"

7 AMENDMENT NO. 11

8 On page 2, delete lines 27 through 29 in their entirety and insert in lieu thereof the following:

9 **"(ii) Following receipt of the petition, a local election shall be called and**  
10 **conducted by the governing authority of each municipality or**  
11 **unincorporated area in whose jurisdiction the water system provides**  
12 **service if the water system has been created or franchised by a**  
13 **municipality. The local election shall be limited to precincts in those**  
14 **municipalities and unincorporated areas which are served by the**  
15 **municipal water system. Alternately, following receipt of the petition,**  
16 **a local election shall be called and conducted by the governing authority**  
17 **of each parish in whose jurisdiction the water system provides service if**  
18 **the water system has been created or franchised by a parish.**"

19 AMENDMENT NO. 12

20 On page 3, at the beginning of line 1, change "**(c)**" to "**(iii)**"

21 AMENDMENT NO. 13

22 On page 3, line 5, change "**(d)**" to "**(iv)**" and between "**same**" and "**took**" delete  
23 "**municipality**" and insert "**jurisdiction**"
