Ernst HB No. 565

Abstract: Extends the duration of the period of informal adjustments for juveniles to a maximum of two years, and clarifies that the consent of the district attorney is required when the court utilizes a teen or youth court program when entering into an informal adjustment agreement.

<u>Present law</u>, with regard to juvenile delinquency matters, authorizes the district attorney, or the court with the consent of the district attorney, to authorize an informal adjustment agreement. Provides that the court has the authority to utilize teen or youth court programs when entering into informal adjustment agreements.

<u>Proposed law</u> retains <u>present law</u> and requires the consent of the district attorney in order for the court to utilize teen or youth court programs.

<u>Present law</u> provides that the period of informal adjustment shall not exceed six months, with one additional period not to exceed six months.

<u>Proposed law</u> amends <u>present law</u> to increase the total informal adjustment period <u>from</u> one year <u>to</u> two years.
