HOMELAND SECURITY: Provides civil immunity for certain volunteers working in coordination with the state or its political subdivisions

AN ACT

2	To enact R.S. 29:735.3.1, relative to homeland security; to provide civil immunity during
3	a declared state of emergency; to provide immunity for gratuitous volunteers
4	providing care in coordination with the state or political subdivisions; to provide an
5	exception for gross negligence or willful misconduct; to provide an exception for
6	care which requires a license; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 29:735.3.1 is hereby enacted to read as follows:
9	§735.3.1. Immunity for volunteers
10	A. During a declared state of emergency, any natural or juridical person, who
11	gratuitously and voluntarily renders any disaster relief or recovery services in
12	coordination with the state or its political subdivisions shall not be liable to the
13	recipient thereof for any injury or death to a person or any damage to property
14	resulting therefrom, except in the event of gross negligence or willful misconduct.
15	B. This Section shall not apply to unlicensed persons providing care,
16	assistance, goods, or services for which a license is required.

Landry HB No. 554

Abstract: Provides immunity for certain volunteers during a declared state of emergency.

<u>Proposed law</u> provides that any person in coordination with the state or its political subdivisions who gratuitously and voluntarily renders any disaster relief or recovery services shall not be civilly liable for causing death or injury to a person or property, unless the damage was intentional or caused by a grossly negligent act of the provider.

<u>Proposed law</u> shall not apply to any licensed insurer of any person covered under the provisions of this Section.

Summary of Amendments Adopted by House

House Floor Amendments to the engrossed bill.

1. Specifies that the person must gratuitously and voluntarily render any disaster relief or recovery services to be entitled to immunity.
