1	AN ACT
2	To amend and reenact R.S. 36:4(U), R.S. 43:111(A)(9), and R.S. 51:1317, 1318(A) and (D),
3	and 1319(A)(1), (2), (3), (4), and (B)(5), relative to the Louisiana Retirement
4	Development Commission; to change the name of the commission to the Encore
5	Louisiana Commission; to provide that the commission shall market Louisiana to
6	persons fifty years old and above; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 36:4(U) is hereby amended and reenacted to read as follows:
9	§4. Structure of executive branch of state government
10	A. In accordance with the provisions of Article IV, Section 1 and Article
11	XIV, Section 6 of the Constitution of Louisiana, all offices, boards, commissions,
12	agencies, and instrumentalities of the executive branch of state government, whether
13	constitutional or statutory, and/or their functions, powers, duties, and responsibilities
14	shall be allocated, either in the Act by which this Title was created or by legislation
15	enacted subsequent thereto, within the departments listed in this Section, except as
16	provided in Subsections B and C of this Section, and in order to comply with this
17	constitutional mandate, the agencies of the executive branch of state government
18	hereinafter enumerated, whether heretofore created by the constitution or by statute,
19	and/or their functions, powers, duties, and responsibilities are allocated, in the
20	manner hereinafter set forth in this Title, within the following designated
21	departments:

23	U. The Louisiana Retirement Development Encore Louisiana Commission,
24	as provided for in R.S. 51:1317 through 1319, shall be placed within the office of the
25	lieutenant governor and shall exercise its powers, duties, and functions as provided
26	by law.

1	Section 2. R.S. 43:111(A)(9) is hereby amended and reenacted to read as follows:
2	§111. Advertising; when prohibited and when authorized
3	A. The state, or any department, officer, board or commission shall not
4	expend any public funds for advertising in any newspaper, book, pamphlet,
5	periodical, or radio and television stations except as follows:
6	* * *
7	(9) Advertising by the Louisiana Retirement Development Encore Louisiana
8	Commission that is designed specifically to both increase the number of Louisianians
9	who remain in the state and to authorize the commission to distribute advertising
10	designed to promote Louisiana as a quality retirement state for residents and
11	tourists in the fifty year old and above demographic.

13	Section 3. R.S. 51:1317, 1318(A) and (D), and 1319(A)(1), (2), (3), (4), and (B)(5)
14	are hereby amended and reenacted to read as follows:
15	§1317. Legislative findings and determinations
16	A. Because the legislature recognizes the existence of an emerging retirement
17	industry with the fifty year old and above demographic, it finds that the state has
18	a role and responsibility in developing Louisiana as a retirement community state
19	desirable place of residence for this age cohort. The legislature also recognizes
20	that retirces residents and tourists fifty years old and above spend a
21	disproportionate amount of their disposable income on goods and services, which in
22	turn creates new jobs. In addition, tax dollars generated from retirees' these incomes
23	provide a boost to state and local economies. The legislature also finds that major
24	aspects of this emerging retirement industry are related directly to both tourism and
25	economic development and that there should be a concerted effort by the state to
26	focus on or serve the growing retirement fifty year old and above market.
27	B. Because the retirement industry fifty year old and above demographic
28	is a potential source of economic growth for Louisiana, the legislature determines it
29	is necessary and essential to create the Louisiana Retirement Development Encore
30	Louisiana Commission to engage in developing, promoting, and marketing

3	§1318. Creation of the Louisiana Retirement Development Encore Louisiana
4	Commission; domicile; composition; membership; officers; staff;
5	expenses; terms; quorum
6	A. The Louisiana Retirement Development Encore Louisiana Commission,
7	hereinafter referred to as the "commission", is hereby created as an agency of the
8	state in the office of the lieutenant governor. The commission shall be a body politic
9	and corporate entity with the power to sue and be sued. The commission shall be
10	domiciled in Baton Rouge.
11	* * *
12	D. All members shall be knowledgeable, interested, and active in developing,
13	marketing, and promoting Louisiana as a retirement community state desirable
14	place of residency for persons fifty years old and above.
15	* * *
16	§1319. Commission responsibilities and duties
17	A. The commission shall have the following responsibilities:
18	(1) Formulate, jointly with the office of the lieutenant governor, a strategic
19	plan, or any modifications thereto, for retirement development attraction and
20	retention of persons fifty years old and above.
21	(2) Monitor and evaluate program guidelines for a designation program
22	that recognizes to award Louisiana assets and developments attractive to
23	residents and tourists fifty years old and above communities with a "Livable
24	Louisiana Retirement Ready" seal of approval.
25	(3) Approve a marketing or communication strategy to promote Louisiana as
26	a retirement location or destination for residents and tourists fifty years old and
27	<u>above</u> .
28	(4) Research, study, and develop plans and programs designed to assist state
29	government, units of local government, private sector entities, and nonprofit entities
30	in developing Louisiana as a retirement destination for residents and tourists fifty
