**Purpose of Bill**: This measure redistricts the 16 election divisions of the 24th Judicial District Court (JDC) into three election sections with 16 subsections (or divisions). The 24th JDC currently has 16 judges and that number will not change because of this measure. This bill will become effective at the regularly scheduled elections in 2014.
