Anders HB No. 229

Abstract: Provides relative to compensation that may be paid to the governing board of Concordia Parish Hospital Service District No. 1.

<u>Present law</u> authorizes parishes to create hospital service districts. Provides that the governing authority of the parish in which the district is located may permit a per diem to each member of the commission of not less than \$25 nor more than \$40 for each day of the member's attendance at meetings of the commission.

<u>Proposed law</u> provides that the governing authority of Concordia Parish may permit a per diem to each member of Concordia Parish Hospital Service District No. 1 of not less than \$25 nor more than \$100 for each day of the member's attendance at meetings of the commission.
