PUBLIC CONTRACTS: Extends the length of time relative to the utilization of design-build contracts

AN ACT

2	To amend and reenact R.S. 38:2225.2.1(A)(3), relative to public contracts; to extend the
3	time relative to the utilization of design-build contracts under certain circumstances;
4	and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 38:2225.2.1(A)(3) is hereby amended and reenacted to read as
7	follows:
8	§2225.2.1. Design-build contracts; authorized use by certain public entities in areas
9	damaged by Hurricane Katrina, Hurricane Rita, or both

12	(3) For the purposes of this Section, "design-builder" means the entity
13	contractually responsible for delivering the project design and construction. This
14	authority shall extend for six seven years from July 10, 2007, after which time only
15	those projects that were contracted for prior to that date may proceed.

Brossett HB No. 559

**Abstract:** Extends the length of time <u>from</u> six years <u>to</u> seven years for the utilization of the design-build method for projects of certain parishes or entities.

<u>Present law</u>, relative to the Public Bid Law, authorizes the following public entities to utilize the design-build method in the construction or repair of any public building or structure which was destroyed or damaged by Hurricane Katrina, Hurricane Rita, or both; the division of administration; the Recovery School District; the Orleans Parish School Board; the city of New Orleans; the Sewerage and Water Board of New Orleans; and parish governments in Calcasieu, Cameron, Jefferson, Orleans, Plaquemines, St. Bernard, St. Tammany, and Vermilion parishes; and the Port of New Orleans.

<u>Present law</u> provides that the authority granted in <u>present law</u> extends for six years from July 10, 2007, after which time only those projects that were contracted for prior to such termination date may proceed.

<u>Proposed law</u> extends the length of time <u>from</u> six years <u>to</u> seven years, or until July 10, 2014, for the utilization of the design-build method for projects of certain parishes or entities under present law.
