SPECIAL DAY/WEEK/MONTH: Designates May 1, 2013, as FFA Day at the legislature and commends the state officers of FFA

1 A RESOLUTION

2 To designate May 1, 2013, as "FFA Day" at the legislature and to commend the state
3 officers of FFA.

4 WHEREAS, the national Future Farmers of America (FFA) organization prepares
5 and trains students for leadership and professions in the science, business, and technology
6 of agriculture in public schools throughout our nation; and

7 WHEREAS, the mission of the FFA organization is to make a positive difference in
8 the lives of young people by developing their potential for premier leadership, personal
9 growth, and career success through agricultural education; and

10 WHEREAS, the motto of the FFA organization, "Learning to Do, Doing to Learn,
11 Earning to Live, Living to Serve" gives members words to live by as they experience the
12 opportunities of the organization; and

13 WHEREAS, the national FFA organization consists of over five hundred fifty-seven
14 thousand members in the fifty states, Puerto Rico, and the Virgin Islands; and

15 WHEREAS, the Louisiana membership of the FFA organization continues to be
16 strongly represented by agricultural students in approximately one hundred eighty-six
17 chapters throughout the state with nearly ten thousand members; and

18 WHEREAS, the members of the Louisiana House of Representatives recognize the
19 importance of agriculture to the economy of this state, as well as the importance of the
20 education and training students receive through agricultural education programs that develop
21 competent and assertive agricultural leadership.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the
2 Legislature of Louisiana does hereby designate May 1, 2013, as "FFA Day" at the
3 legislature.

4 BE IT FURTHER RESOLVED that the House of Representatives of the Legislature
5 of Louisiana also recognizes and commends the 2012-2013 state FFA officers as follows:
6 Nicholas Adams, President; Katie Whitehead, Vice President, Area I; Gregory Simmons,
7 Vice President, Area II; Gabriel Fontenot, Vice President, Area III; William Mayfield, Vice
8 President, Area IV; Aaron Babers, Secretary; Victoria Novitsky, Treasurer; and Camille
9 Mouton, Sentinel.
