1	AN ACT
2	To amend and reenact R.S. 32:387.12(A), relative to annual noncritical off-road equipment
3	permits; to allow noncritical off-road equipment with additional axle configurations
4	to obtain an annual permit; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 32:387.12(A) is hereby amended and reenacted to read as follows:
7	§387.12. Annual noncritical off-road equipment permit; authorization
8	A. Notwithstanding any other provision of law to the contrary, the secretary
9	shall promulgate rules and regulations in accordance with the Administrative
10	Procedure Act as may be necessary to provide for an annual noncritical off-road
11	equipment permit. "Noncritical off-road equipment" means either vehicles or
12	combinations of vehicles without booster units, or vehicles with a single-single,
13	single-tandem, single-triple, or tandem-tandem axle configuration in which no single
14	axle is in excess of thirty thousand pounds nor tandem or triple axles in excess of
15	fifty-four thousand pounds, as defined in the manual entitled "Louisiana Regulations
16	for Trucks, Vehicles and Loads", or those vehicles classified as noncritical off-road
17	equipment by the department.

Abstract: Provides for an annual noncritical off-road equipment permit to be issued by DOTD for vehicles or combinations of vehicles with single-triple axle configurations in which no single axle is in excess of 30,000 pounds nor triple axle is in excess of 54,000 pounds.

<u>Present law</u> provides for an annual noncritical off-road equipment permit to be issued by DOTD for vehicles or combinations of vehicles without booster units, or vehicles with a single-single, single-tandem, or tandem-tandem axle configuration in which no single axle is in excess of 30,000 pounds nor tandem axles in excess of 54,000 pounds.

<u>Proposed law</u> includes single-triple axles not in excess of 30,000 pounds and triple axles not in excess of 54,000 pounds in the list of vehicles eligible for such permits.
