<u>Present law</u> provides for a section of insurance fraud within the Louisiana Department of Insurance (LDI) and provides for certain responsibilities. <u>Proposed law</u> creates a division of insurance fraud and a deputy commissioner of insurance fraud with responsibilities as provided in <u>present law</u> and adds certain powers and duties; provides that if a violation of any criminal law is uncovered that it be turned over to certain agencies for further investigation, enforcement or prosecution; provides for actions in the determination of fraud; creates the division of insurance fraud and confers investigate powers and priveleges including access to criminal records systems; permits the deputy commissioner to issue a commission authorizing the carry and use of firearms by POST certified investigators.

EXPENDITURE EXPLANATION

<u>Proposed law</u> is anticipated to result in an increase in SGR expenditures by LDI. <u>Proposed law</u> creates a division of insurance fraud and a deputy commissioner with the authority to authorize the carry and use of firearms by POST certified investigators and permitting them to conduct criminal investigations. LDI projects a first year expenditure of approximately \$70,500, and a second year expenditure of approximately \$28,400 (see below). <u>Proposed law</u> will create no new T.O positions. The department previously received Civil Service approval to create an unclassified Director position to administer this unit. <u>Proposed law</u> would change this position's title to Deputy Commissioner of Insurance Fraud. Additionally, Civil Service already reclassified the titles of employees within this workgroup as Compliance Investigators. As such, <u>proposed law</u> provides structural changes, creates the insurance fraud division and an unclassified job title. There will be no adjustments to salary associated with the proposed changes. LDI anticipates approximately two to four of the investigators in this section will be commissioned to carry and use firearms at any given time, with the remaining employees serving as non-POST certified investigators.

There are currently 9 T.O. positions in the insurance fraud investigation section, including one director, one administrative assistant, and seven investigators (2 currently vacant).
