HOMELAND SECURITY: Provides relative to the creation of a statewide mapping and planning system for certain schools

AN ACT

2 To amend and reenact R.S. 29:726.3(A), (C)(2), and (D)(1) and to enact R.S. 29:726.3(C)(3) 3 and (G)(3), (4), and (5), relative to the Louisiana Homeland Security and Emergency 4 Assistance and Disaster Act; to provide for the development, operation, and 5 maintenance of a critical incident planning and mapping system for nonpublic 6 schools, proprietary schools, and nonpublic colleges and universities; to provide for 7 responsibilities of each local parish office of emergency preparedness and the 8 Governor's Office of Homeland Security and Emergency Preparedness; to require 9 that certain entities provide critical information to be included in the system; to 10 provide for definitions; and to provide for related matters. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. R.S. 29:726.3(A), (C)(2), and (D)(1) are hereby amended and reenacted 13 and R.S. 29:726.3(C)(3) and (G)(3), (4), and (5) are hereby enacted to read as follows: 14 §726.3. Critical Incident Planning and Mapping System 15 A. To the extent that sufficient funds are appropriated to implement the 16 provisions of this Section, the Governor's Office of Homeland Security and 17 Emergency Preparedness shall develop, operate, and maintain a statewide critical 18 incident planning and mapping system for all public buildings, nonpublic schools,

For purposes of this Section, "nonpublic 23 school" shall exclude any home study program. 24 (5) "Proprietary school" means any business enterprise operated for a profit 25 that is approved by the Board of Regents and maintains a physical building in this 26 state where a course or courses of instruction or study are offered in a classroom. 27 Section 2. This Act shall become effective upon signature by the governor or, if not 28 signed by the governor, upon expiration of the time for bills to become law without signature 29 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. Brossett HB No. 212

Abstract: Authorizes the creation of a statewide planning and mapping system for nonpublic schools, proprietary schools, and nonpublic colleges and universities to assist first responders in a disaster or emergency.

<u>Present law</u> requires the Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP) to create a statewide critical incident planning and mapping system for all public buildings in this state to assist first responders when responding to a disaster or emergency. Requires GOHSEP to acquire a computer system and software that has the capability of storing critical information required by <u>present law</u> and to grant access to that information to all first responders.

<u>Proposed law</u> retains <u>present law</u> and adds the inclusion of nonpublic schools, proprietary schools, and nonpublic colleges and universities to the statewide planning and mapping system.

<u>Proposed law</u> requires that each nonpublic school, proprietary school, and nonpublic college or university provide critical information for their buildings located in this state to their local parish office of emergency preparedness, to be uploaded to the Virtual La. System for inclusion in the system by GOHSEP, and further provides for the use of critical information by first responders.

<u>Proposed law</u> requires GOHSEP to adopt rules in accordance with the APA to implement <u>proposed law</u> and provides that <u>proposed law</u> is contingent upon the appropriation of funds.

<u>Proposed law</u> provides for definitions.

Effective upon signature of governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by House

Committee Amendments Proposed by House Committee on Judiciary to the original bill.

1. Provided for the definition of "known hazards" to include any hazard which might compromise the physical structure of the building or its occupants creating an emergency situation requiring a response from certain first responder organizations. Further provided that the hazards should be made known to first responders in certain incidents.
