
SENATE FLOOR AMENDMENTS

Amendments proposed by Senator Martiny to Engrossed Senate Bill No. 18 by Senator Ward

1 AMENDMENT NO. 1

2 On page page 1, line 6, after "Professionals;" add "to provide for exceptions;"

3 AMENDMENT NO. 2

4 In Senate Floor Amendment No. 4 proposed by Senator Heitmeier and adopted by the Senate
5 on May 7, 2013, on page 1, line 16, change "A." to "A.**(1)(a)**"

6 AMENDMENT NO. 3

7 In Senate Floor Amendment No. 4 proposed by Senator Heitmeier and adopted by the Senate
8 on May 7, 2013, on page 1, between lines 21 and 22, insert the following:

9 **"(b) The provisions of Subparagraph (a) of this Paragraph shall not**
10 **apply to any preparer of cakes and cookies who employs any individual to assist**
11 **in the preparation of such cakes and cookies.**

12 **(2) Notwithstanding any provision of law to the contrary, the following**
13 **provisions of the state Sanitary Code shall apply to the preparation of cakes and**
14 **cookies in the home for sale:**

15 **(a) All outside openings shall be protected against flies and other**
16 **vermin.**

17 **(b) The building shall be constructed so as to exclude rats, mice, roaches**
18 **or other vermin. Domestic pets shall be excluded in any part of the**
19 **establishment.**

20 **(c) All equipment used or connected in any way with the manufacture,**
21 **baking, cooking or other processing, handling, packing or storing of any bakery**
22 **or confectionery product shall comply with the following:**

23 **(i) Be maintained in a clean and sanitary manner, be free from cracks**
24 **and wherever possible, be of non-corroding, metal or other smooth, impervious**
25 **material giving an easily cleanable surface. Stationary or not readily movable**
26 **equipment shall be so installed as to provide for easy cleaning.**

27 **(ii) Refrigeration shall be provided so that all perishable food products**
28 **used in the manufacturer processing of any kind connected with the production,**
29 **distribution or sale of bakery or confectionery products shall be maintained at**
30 **a temperature not to exceed forty-five degrees Fahrenheit.**

31 **(iii) Equipment too large to permit washing in the sinks shall be cleaned**
32 **in a manner approved by the state health officer.**

33 **(iv) All barrels, boxes, tubs, pails, kneading troughs, machines, racks,**
34 **pans or other receptacles used for holding materials from which bakery or**
35 **confectionery products are manufactured shall be kept clean and sanitary and**
36 **shall be so constructed as to be easily cleanable.**

37 **(v) All food contact surfaces shall be cleaned and sanitized after each**
38 **day's production.**

39 **(d) Only pasteurized milk or milk products shall be used in the**
40 **preparation of custard and cream-filled bakery products.**

41 **(e) All custard or cream-filled mixtures shall be cooked, the temperature**
42 **and time of heating of the mix, to be at a minimum, the equivalent of a**
43 **temperature of one hundred forty-five degrees Fahrenheit for a period of not**
44 **less than thirty minutes.**

45 **(f) Upon completion of the cooking of the mix, it shall be immediately**
46 **transferred into previously sanitized containers, properly covered and chilled**
47 **as rapidly as possible to forty-five degrees Fahrenheit or below and maintained**
48 **at such a temperature until used.**

1 **(g) The apparatus and food contact surfaces used in adding any custard**
2 **or cream filling to a bakery product shall be of impervious material and shall**
3 **be thoroughly cleaned and sanitized after each use, in a manner approved by**
4 **the state health officer. No cloth filled bags shall be used.**

5 **(h) Preparers engaged in the preparation of custard or cream-filled**
6 **bakery products shall not touch the custard or cream filling with their hands**
7 **after it has been cooked.**

8 AMENDMENT NO. 4

9 In Senate Floor Amendment No. 4 proposed by Senator Heitmeier and adopted by the Senate
10 on May 7, 2013, on page 1, between lines 24 and 25, insert the following:

11 **"C. Any individual selling cookies and cakes from the home for sale to the**
12 **public pursuant to this Section shall not sell such cakes and cookies to any retail**
13 **business or individual for resale."**

14 AMENDMENT NO. 5

15 In Senate Floor Amendment No. 4 proposed by Senator Heitmeier and adopted by the Senate
16 on May 7, 2013, on page 1, line 25, change "C." to "**D.**"
