HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Schroder to Engrossed House Bill No. 571 by Representative Robideaux

1 AMENDMENT NO. 1

2 On page 1, line 2, after "1791" and before the comma "," insert the following:

3 "and to enact R.S. 47:6302 and R.S. 51:3116 and 3122"

4 AMENDMENT NO. 2

5 On page 1, between lines 6 and 7, insert the following:

6 Section 1. R.S. 47:6302 is hereby enacted to read as follows:

7 "§ 6302. Suspension of Rebate

8 A. Notwithstanding any provision of law to the contrary, the provisions of
9 this Chapter and the authorization to issue or pay a rebate shall be ineffective
10 beginning on and after July 1, 2013, through June 30, 2016. Beginning July 1, 2016,
11 the provisions of this Chapter and the authority to issue or pay a rebate shall have the
12 full force and effect of law.

13 B. The provisions of this Section shall not apply with respect to the
14 satisfaction of any claim for a rebate based on a donation made between January 1,
15 2013, and June 30, 2013."

17 AMENDMENT NO. 3

18 On page 1, at the beginning of line 7, change "Section 1." to "Section 2."

19 AMENDMENT NO. 4

20 On page 3, between lines 16 and 17, insert the following:

21 " * * *

22 § 3116. Suspension of Rebate

23 A. Notwithstanding any provision of law to the contrary, the provisions of
24 this Chapter and the authorization to enter into any rebate contract shall be
25 ineffective beginning on and after July 1, 2013, through June 30, 2016. Beginning
26 July 1, 2016, the provisions of this Chapter and the authority to enter into any rebate
27 contract shall have the full force and effect of law."

28 B. The provisions of this Section shall not apply in cases where the secretary
29 of the Department of Economic Development has entered into a cooperative
30 endeavor agreement with a business entity for purposes of receiving this rebate

1 incentive, regardless of whether the contract has been approved by the Joint
2 Legislative Committee on the Budget prior to July 1, 2013.

4 § 3122. Suspension of Rebate

5 A. Notwithstanding any provision of law to the contrary, the provisions of
6 this Chapter and the authorization to enter into any rebate contract shall be
7 ineffective beginning on and after July 1, 2013, through June 30, 2016. Beginning
8 July 1, 2016, the provisions of this Chapter and the authority to enter into any rebate
9 contract shall have the full force and effect of law.

10 B. The provisions of this Section shall not apply in cases where the secretary
