Harrison HB No. 101

Abstract: Provides for transfer by the state treasurer of funds appropriated to a state agency other than the agency which has the legal authority to perform the purpose, function, or program being funded.

<u>Present constitution</u> establishes the powers and duties of the state treasurer.

<u>Proposed constitutional amendment</u> provides that if an appropriation is made to a state department or agency to fund a purpose, function, or program that is within the constitutional, codal, or statutory authority of another state department or agency rather than the authority of the department or agency to which the appropriation is made, then the state treasurer is required to redirect such funds to the constitutional, codal, or statutorily appropriate department or agency.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 4, 2014.
