2	To amend and reenact R.S. 38:2225.2.1(A)(3) and to enact R.S. 38:2225.2.1(A)(4), (5), and
3	(6), relative to public contracts; to extend the time relative to the utilization of
4	design-build contracts under certain circumstances; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 38:2225.2.1(A)(3) is hereby amended and reenacted and R.S.
8	38:2225.2.1(A)(4), (5), and (6) are hereby enacted to read as follows:
9	§2225.2.1. Design-build contracts; authorized use by certain public entities in areas
10	damaged by Hurricane Katrina, Hurricane Rita, or both
11	A.

13	(3) For the purposes of this Section, "design-builder" means the entity
14	contractually responsible for delivering the project design and construction.
15	(4) Except as provided in Paragraphs (5) and (6) of this Subsection, This the
16	authority to use the design-build method shall extend for six years from July 10,
17	2007, after which time only those projects that were contracted for prior to that date
18	may proceed.
19	(5) The authority to use the design-build method shall extend for seven years
20	from July 10, 2007, for the following schools, after which time only those projects
21	that were contracted prior to that date may proceed:
22	(a) Edna Karr High School.
23	(b) G. W. Carver High School.

This Act shall become effective on July 1, 2013; if vetoed by the governor 10 and subsequently approved by the legislature, this Act shall become effective on July 1, 11 2013, or on the day following such approval by the legislature, whichever is later.
