AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2014-3 2015 to be used to pay the consent judgment in the suit entitled "Muhammad Juneno 4 Iqbal individually and on behalf of the estate of his wife Talat Iqbal, Sahar Iqbal, 5 individually and on behalf of the minors, Shanze Al Qadri and Alizay Al Qadri, 6 Khurram Iqbal Junejo, Erum Mahfooz, and Sadaf Omer v. Daniel C. Adams, Hatten 7 Tire Center, Inc., Lafayette Insurance Company, Excalibur Family Fun 8 Entertainment Center, Inc., ABC Insurance Company, and the State of Louisiana 9 through the Department of Transportation and Development"; to provide for court 10 costs; and to provide for related matters. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. The sum of Two Hundred Thousand and No/100 (\$200,000.00) Dollars, 13 plus court costs in the amount of Two Thousand Seven Hundred Eighty-One and No/100 14 (\$2,781.00) Dollars, is hereby appropriated out of the General Fund of the state of Louisiana 15 for Fiscal Year 2014-2015 to be used to pay the consent judgment in the suit entitled 16 "Muhammad Juneno Iqbal individually and on behalf of the estate of his wife Talat Iqbal, 17 Sahar Iqbal, individually and on behalf of the minors, Shanze Al Qadri and Alizay Al Qadri, 18 Khurram Iqbal Junejo, Erum Mahfooz, and Sadaf Omer v.
