APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment in the matter of "Chester Barrilleaux, et al v. State of Louisiana DOTD"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2014-3 2015 to be used to pay the judgment in the suit entitled "Chester Barrilleaux, 4 individually and as administrator of the estate of his minor children, Dustin 5 Barrilleaux, and Hunter Barrilleaux, and Melissa Barrilleaux, and Tiffany Barrilleaux Meador v. State of Louisiana, Department of Transportation and Development"; to 6 7 provide for interest; to provide for court costs; and to provide for related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1.A. The sum of One Million Seven Hundred Forty-Six Thousand Eight 10 Hundred Fifty-One and 78/100 (\$1,746,851.78) Dollars in favor of Melissa Barrilleaux; the 11 sum of Two Hundred Seven Thousand Four Hundred Twenty-Seven and 96/100 12 (\$207,427.96) Dollars in favor of Chester Barrilleaux; the sum of Six Thousand Five 13 Hundred Seventy and No/100 (\$6,570.00) Dollars in favor of Tiffany Meador; the sum of 14 Four Thousand Nine Hundred Twenty-Seven and 50/100 (\$4,927.50) Dollars in favor of 15 Hunter Barrilleaux; the sum of One Thousand Six Hundred Forty-Two and 50/100 16 (\$1,642.50) Dollars in favor of Dustin Barrilleaux; plus legal interest from May 7, 2007, 17 until paid, plus costs including expert witness fees, deposition costs, court costs, cost of trial 18 exhibits, etc., in the amount of Twenty-Three Thousand Sixty-Six and 06/100 (\$23,066.06) 19 Dollars, are hereby appropriated out of the General Fund of the state of Louisiana for Fiscal 20 Year 2014-2015 to be used to pay the judgment in the suit entitled "Chester Barrilleaux, 21 individually and as administrator of the estate of his minor children, Dustin Barrilleaux and

- 3 Division A, on the docket of the Eighteenth Judicial District Court, parish of West Baton
- 4 Rouge, state of Louisiana.
- 5 B. Monies awarded in this judgment to Melissa Barilleaux in the amount of One
- 6 Hundred Thirty-Seven Thousand Two Hundred Thirty-Seven and No/100 (\$137,237.00)
- 7 Dollars for future medical expenses shall be payable from the Future Medical Care Fund
- 8 pursuant to R.S. 39:1533.2.
- 9 Section 2. The judgment provided for in Section 1 hereof shall be deemed to have
- been paid on the effective date of this Act and legal interest shall cease to run as of that date.
- Section 3. This Act shall become effective on July 1, 2014; if vetoed by the governor
- and subsequently approved by the legislature, this Act shall become effective on July 1,
- 13 2014, or on the day following such approval by the legislature, whichever is later.
