CRIMINAL/PROCEDURE: Amends responsive verdicts for theft and attempted theft

AN ACT

2	To amend and reenact Code of Criminal Procedure Article 814(A)(26) and (27), relative to
3	responsive verdicts; to provide changes in responsive verdicts for theft and attempted
4	theft; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. Code of Criminal Procedure Article 814(A)(26) and (27) are hereby
7	amended and reenacted to read as follows:
8	Art. 814. Responsive verdicts; in particular
9	A. The only responsive verdicts which may be rendered when the indictment
10	charges the following offenses are:
11	* * *
12	26. Theft:
13	Guilty of theft of property having a value of one thousand five hundred
14	dollars or more.
15	Guilty of theft of property having a value of five hundred dollars or more, but
16	less than one thousand five hundred dollars.
17	Guilty of theft of property having a value of three hundred dollars or more,
18	but less than five hundred dollars.
19	Guilty of theft of property having a value of less than three five hundred
20	dollars.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

1	Guilty of attempted theft of property having a value of one thousand five
2	hundred dollars or more.
3	Guilty of attempted theft of property having a value of three five hundred
4	dollars or more, but less than one thousand five hundred dollars.
5	Guilty of attempted theft of property having a value of less than three five
6	hundred dollars.
7	Guilty of unauthorized use of movables having a value in excess of five
8	hundred dollars.
9	Guilty of unauthorized use of movables having a value of five hundred
10	dollars or less.
11	Not guilty.
12	27. Attempted Theft:
13	Guilty of attempted theft of property having a value of one thousand five
14	hundred dollars or more.
15	Guilty of attempted theft of property having a value of three five hundred
16	dollars or more, but less than one thousand five hundred dollars.
17	Guilty of attempted theft of property having a value of less than three five
18	hundred dollars.
19	Guilty of attempted unauthorized use of movables having a value of less than
20	one hundred dollars.
21	Guilty of attempted unauthorized use of movables having a value in excess
22	of five hundred dollars.
23	Guilty of attempted unauthorized use of movables having a value of five
24	hundred dollars or less.

**Abstract:** Changes the property value amounts for responsive verdicts for theft and attempted theft to be consistent with the gradations of theft.

<u>Present law</u> provides that the following are responsive verdicts for theft and attempted theft: guilty of theft or attempted theft of property having a value in excess of \$500, property having a value of less than \$500 but more than \$300, and property having a value of less than \$300.

<u>Proposed law</u> changes <u>present law</u> amounts to be consistent with the crime of theft (R.S. 14:67) as follows: guilty of theft or attempted theft of property in excess of \$1,500, property having a value of less than \$1,500 and more than \$500, and property having a value of less than \$500.
