PUBLIC TRANSPORTATION. Requires training for members of boards or commissions of regional transit entities. (8/1/14)

AN ACT

2 To enact Chapter 11 of Title 48 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 48:1501, relative to regional public transportation; to provide for the 3 4 development and implementation of training of members of boards and commissions 5 of regional public transit entities; to require training for such membership; to provide 6 that the lack of training is a cause for removal; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. Chapter 11 of Title 48 of the Louisiana Revised Statutes of 1950, 9 comprised of R.S. 48:1501, is hereby enacted to read as follows: 10 CHAPTER 11. REGIONAL PUBLIC TRANSPORTATION 11 §1501. Training required of members of boards of regional transit entities A. All appointed members of a regional transit entity board shall receive 12 13 and complete at least six hours of training in the duties, responsibilities, ethics, and substance of the positions held or to be held, either prior to taking office or 14 not later than one year after taking office. The training shall be developed by 15 or through, and approved by, the governing authority of the parish in which the 16 17 respective entity is domiciled.

1	B. The provisions of this Section shall only apply to persons appointed
2	to a board on or after January 1, 2015.
3	C. As used in this Section, the following terms shall have the following
4	meaning, unless the context requires otherwise:
5	(1) "Board" means the board or commission which serves as the
6	governing body of a regional transit entity.
7	(2) "Regional transit entity" includes each area public transit system
8	and regional public transit authority which administers a public transit system
9	within a metropolitan area that is created by law as a political subdivision of the
10	state.
11	D. Failure of a member to receive and complete the training required
12	by this Section either prior to taking office or within the first year after the
13	member takes office shall be cause for removal from the board.

DIGEST

Broome (SB 310)

Proposed law requires all appointed members of a regional transit entity board to receive and complete at least six hours of training in the duties, responsibilities, ethics, and substance of the positions held or to be held, either prior to taking office or not later than one year after taking office. Requires that the training be developed by or through, and approved by, the governing authority of the parish in which the entity is domiciled.

Provides that <u>proposed law</u> applies only to persons appointed to a board on or after January 1, 2015.

Defines "board" as the board or commission which serves as the governing body of a regional transit entity.

Defines "regional transit entity" to include each area public transit system and regional public transit authority which administers a public transit system within a metropolitan area that is created by law as a political subdivision of the state.

Provides that failure of a member to receive and complete the training required by proposed <u>law</u> either prior to taking office or within the first year after the member takes office shall be cause for removal from the board.

Effective August 1, 2014.
