LEASES: Provides an exemption from the Louisiana Public Lease Law for lease or other alienation of certain property in Lafayette Parish

AN ACT

2 To enact R.S. 41:1224.1, relative to leases and other property transactions involving 3 specified property in Lafayette Parish; to exempt such leases or transactions from 4 general requirements regarding leases of public property, including requirements for advertising and bidding; and to provide for related matters. 5 Notice of intention to introduce this Act has been published 6 7 as provided by Article III, Section 13 of the Constitution of 8 Louisiana. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. R.S. 41:1224.1 is hereby enacted to read as follows: 11 §1224.1. Exceptions to advertisement and bidding requirements 12 The provisions of this Chapter do not apply to leases, sales, exchanges, 13 cooperative endeavor agreements, joint use agreements, and similar or related agreements by any governmental body involving any of the property authorized to 14 15 be transferred to the city of Lafayette by Act No. 385 of the 2009 Regular Session 16 of the Legislature, any parcels adjacent to such property, and any parcels made 17 adjacent as a result of a transaction authorized by this Section. A property alienated 18 pursuant to this Section shall not be subject to any deed restrictions required by Act 19 No. 385 of the 2009 Regular Session of the Legislature.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

- 1 Section 2. This Act shall become effective upon signature by the governor or, if not
- 2 signed by the governor, upon expiration of the time for bills to become law without signature
- 3 by the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If
- 4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 5 effective on the day following such approval.

Robideaux HB No. 992

Abstract: Exempts the lease or other alienation of specified property, locally known as the "Horse Farm", in Lafayette Parish from laws regulating leases of public property, which include requirements for advertising and bidding.

<u>Present law</u> establishes procedures applicable to the lease of public property; generally requires the public entity to publicly advertise the proposed lease to solicit bidders and requires the awarding of the lease to the highest bidder who meets the requirements of law. Provides relative to terms and renewals of such leases. Provides exceptions.

<u>Proposed law</u> provides an additional exception from <u>present law</u> applicable to the lease or other alienation of specified property, locally known as the "Horse Farm" and adjacent property in Lafayette Parish. Otherwise retains <u>present law</u>.

Effective upon signature of governor or lapse of time for gubernatorial action.
