SCHOOLS/CHOICE: Provides relative to student eligibility requirements for the Student Scholarships for Educational Excellence (voucher) Program

AN ACT

2	To enact R.S. 17:4013(2)(d), relative to the Student Scholarships for Educational Excellence
3	Program; to provide that a student is eligible for program participation if his parent
4	or legal guardian determines that the public school he is attending is not a safe
5	environment; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 17:4013(2)(d) is hereby enacted to read as follows:
8	§4013. Definitions
9	As used in this Chapter, unless otherwise clearly indicated, the following
10	terms mean:

12	(2) "Eligible student" means a student who resides in Louisiana, is a member
13	of a family with a total income that does not exceed two hundred fifty percent of the
14	current federal poverty guidelines as established by the federal office of management
15	and budget, and who meets any one of the following criteria:

17	(d) The student's parent or legal guardian determines that the public school
18	the student is attending is not a safe environment for the student due to the
19	occurrence of any of the following:

**Abstract:** Provides that a student is eligible for a voucher from the Student Scholarships for Educational Excellence Program if his parent or legal guardian determines that the public school he is attending is not a safe environment.

<u>Present law</u>, relative to the Student Scholarships for Educational Excellence Program, defines "eligible student" as a student who resides in La., is a member of a family with a total income that does not exceed 250% of the federal poverty guidelines, and who meets any one of the following criteria:

- (1) Is entering kindergarten and has enrolled in the local school system in which the public school he would have otherwise attended is located or has enrolled in a school under the jurisdiction of the Recovery School District (RSD).
- (2) Was enrolled in a public school in La. the previous school year and such school received a letter grade of "C", "D", or "F" or any variation thereof, for the most recent year pursuant to the school and district accountability system.
- (3) Received a scholarship in the previous school year.

<u>Proposed law</u> retains <u>present law</u> and adds as an eligible student, a student whose parent or legal guardian determines that the public school the student is attending is not a safe environment due to the occurrence of any of the following:

- (1) Acts or threats of violence.
- (2) Bullying, including cyberbullying.
- (3) The use of alcohol beverages or illegal drugs.
- (4) Arson.
- (5) Sexual activity.
- (6) Theft of personal property.
