DISTRICTS/FIRE PROTECT: Authorizes Caddo Fire District No. 1 to levy and collect a sales and use tax, subject to voter approval

AN ACT

2 To enact R.S. 40:1501.7, relative to Caddo Parish Fire District No. 1; to authorize the district 3 to levy a sales and use tax, subject to voter approval; and to provide for related 4 matters. 5 Notice of intention to introduce this Act has been published as provided by Article III, Section 13 of the Constitution of 6 7 Louisiana. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. R.S. 40:1501.7 is hereby enacted to read as follows: 10 §1501.7. Caddo Parish Fire District No. 1; authority to levy sales and use tax 11 A. Notwithstanding any other provision of law to the contrary, Caddo Parish 12 Fire District No. 1 may levy and collect a sales and use tax not to exceed one percent 13 pursuant to the provisions of Article VI, Section 30 of the Constitution of Louisiana. 14 Caddo Parish Fire District No. 1 may levy the tax only if the levy of the tax is 15 approved by a majority of the electors in the district who vote on a proposition 16 authorizing the levy of the tax. 17 B. The proceeds of the tax authorized by this Section shall be used for maintaining and operating fire protection facilities, obtaining water for fire 18 protection purposes, or any other lawful purpose as determined by the governing 19 20 board.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

1 C. The sales and use tax so levied shall be imposed by an ordinance of the 2 district and shall be levied upon the sale at retail, the use, the lease or rental, the 3 consumption, the storage for use or consumption of tangible personal property, and 4 on sales of services in the district, all as defined in Chapter 2 of Subtitle II of Title 47 of the Louisiana Revised Statutes of 1950. 5 D. The tax shall be in addition to all other authorized sales and use taxes and 6 7 shall be collected at the same time and in the same manner as other local sales and 8 use taxes. 9 Section 2. This Act shall become effective upon signature by the governor or, if not 10 signed by the governor, upon expiration of the time for bills to become law without signature 11 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 12 vetoed by the governor and subsequently approved by the legislature, this Act shall become 13 effective on the day following such approval.

<u>Proposed law</u> authorizes Caddo Parish Fire District No. 1 to levy a sales and use tax not to exceed 1%, subject to voter approval. Provides that proceeds shall be used for maintaining and operating fire protection facilities, obtaining water, or other lawful purposes.

Effective upon signature of governor or lapse of time for gubernatorial action.
