Proposed bill provides that no private employer shall bid on or otherwise contract with a public entity for the performance of services, the purchase of materials and supplies, or public works within the state unless the private employer attests to: complying with the same pay practices provided in R.S. 23:661 - 669 for state employees and all subcontractors submit to the employer a sworn affidavit verifying that they are also in compliance with R.S. 23:661 - 669. Proposed bill provides that if a public entity discovers a private employer has not complied with this law, he shall send written notice to private employer requiring the private employer to comply no later than 60 days from the date of such notice. Proposed bill provides that if the private employer who fails to comply within 60 days may be subject to cancellation of any of the private employer's public contracts and may be declared ineligible to enter into any public contract for a period of no more than 3 years from the date of violation discovery. Proposed bill provides that any private employer shall be liable for any additional costs incurred by a public entity occasioned by the cancellation of a contract and may be subject to the loss of any license to do business in the state. Proposed bill provides that this bill shall apply only to contracts entered into or bids offered on or after January 1, 2015.
