PROPERTY/PUBLIC: Provides for the authority to transfer or lease certain state property in St. Mary Parish

AN ACT

2 To authorize and provide for the transfer of certain state property; to authorize the transfer 3 of certain state property in St. Mary Parish; to provide for the property description; 4 to provide for reservation of mineral rights; to provide terms and conditions; to 5 provide an effective date; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. The commissioner of administration, notwithstanding any other provision 8 of law to the contrary, is hereby authorized and empowered to convey, transfer, assign, lease 9 or deliver any interest, excluding mineral rights, the state may have to all or any portion of 10 the following described parcel of property to Lawrence Toups, Gloria Toups, Perry Toups, 11 and Erin Toups: 12 Property acquired by the State through that certain tax sale for nonpayment of 1942 13 taxes assessed in the name of MRS. SIDNEY D. HANSON, recorded on June 26, 14 1943, in Book 6-I Page 340 Entry No. 70080, described as "Lot Street, Road, 15 Robertson, Smith." Said property being more fully described as "Lot 11 of the D. C. Roberts Addition to the Town of Berwick, Louisiana". 16 17 Section 2. The commissioner of administration is hereby authorized to enter into 18 such agreements, covenants, conditions, and stipulations and to execute such documents as 19 necessary to properly effectuate any conveyance, transfer, assignment, lease or delivery of 20 title, excluding mineral rights, to the property described in Section 1 of this Act, and as more 21 specifically described in any such agreements entered into and documents executed by and

- 1 between the commissioner of administration and Lawrence Toups, Gloria Toups, Perry
- 2 Toups, and Erin Toups, in exchange of consideration proportionate to the appraised value
- 3 of the property. In the event that Lawrence Toups, Gloria Toups, Perry Toups, and Erin
- 4 Toups do not acquire the property described in Section 1 of this Act on or before December
- 5 31, 2017, the authorization to convey, transfer, assign, lease, or deliver any interest in that
- 6 property shall terminate and be null and void on that date.
- 7 Section 3. This Act shall become effective upon signature by the governor or, if not
- 8 signed by the governor, upon expiration of the time for bills to become law without signature
- 9 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 11 effective on the day following such approval.

Jones HB No. 361

Authorizes the transfer or lease of certain state property in St. Mary Parish <u>from</u> the division of administration <u>to</u> Lawrence Toups, Gloria Toups, Perry Toups, and Erin Toups. Provides for the reservation of mineral rights to the state. Terminates the authority granted in <u>proposed law</u> if the property is not transferred on or before Dec. 31, 2017.

Effective upon signature of governor or lapse of time for gubernatorial action.
