FUNDS/FUNDING: Creates the Louisiana Healthcare Freedom Legal Fund to be used for litigation related to the state's decisions regarding the Affordable Care Act

AN ACT

To enact R.S. 49:260, relative to the Louisiana Healthcare Freedom Legal Fund; to create 3 the Louisiana Healthcare Freedom Legal Fund as a special treasury fund; to provide 4 for deposit, use, and investment of money in the fund; to provide for definitions; and 5 to provide for related matters. Be it enacted by the Legislature of Louisiana: 6 7 Section 1. R.S. 49:260 is hereby enacted to read as follows: 8 §260. Louisiana Healthcare Freedom Legal Fund 9 A. The Louisiana Healthcare Freedom Legal Fund, hereafter referred to as 10 the "fund", is hereby created as a special fund in the state treasury. The source of 11 monies deposited into the fund may include but shall not be limited to any 12 appropriation by the legislature, including federal funds; any public or private 13 donations, gifts, or grants from individuals, corporations, nonprofit organizations, 14 or other business entities; and any other monies which may be provided by law. 15 B. After satisfying the requirements of Article VII, Section 9(B) of the 16 Constitution of Louisiana relative to the Bond Security and Redemption Fund, the 17 treasurer shall deposit into the fund all monies appropriated or donated to the fund 18 as provided for in Subsection A of this Section. 19 C. The monies in the fund shall be invested by the state treasurer in the same 20 manner as monies in the state general fund. Interest earned on the investment of

Hollis HB No. 1041

Abstract: Creates the La. Healthcare Freedom Legal Fund to be used by the Department of Justice to defend the state's healthcare policy decisions regarding implementation, enforcement, and alternatives to the Affordable Care Act.

Proposed law creates the La. Healthcare Freedom Legal Fund as a special treasury fund and further provides that the source of monies for the fund may include any appropriation by the legislature, including federal funds; any public or private donations, gifts, or grants from individuals, corporations, nonprofit organizations, or other business entities; and any other monies which may be provided by law.

<u>Proposed law</u> provides that monies in the fund shall be appropriated to the Dept. of Justice to defend the state's healthcare policy decisions regarding implementation, enforcement, and alternatives to the Affordable Care Act.
