INSURANCE: Provides relative to continuing education requirements

1	AN ACT
2	To amend and reenact R.S. 22:1573(I)(1) and (3), (J), (K), (L), and (M), relative to insurance
3	producer continuing education requirements; provides that the commissioner shall
4	grant twenty-four continuing education credits to a licensed producer who is a
5	member of the legislature during the member's term; provides that a licensed
6	producer who actively participates in a state or national insurance association may
7	receive up to four continuing education credits; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 22:1573(I)(1) and (3), (J), (K), (L), and (M) are hereby amended and
10	reenacted to read as follows:
11	§1573. Continuing education requirements
12	* * *
13	I.(1)(a) The provisions of this Section, imposing continuing education
14	requirements for renewal of a license, shall not apply to any person sixty-five years
15	of age or older on January 1, 2012, who has at least fifteen years of experience as a
16	licensed producer and who either:
17	(i)(a) Is no longer actively engaged in the insurance business as a producer
18	and who is receiving social security benefits, if eligible.
19	(ii)(b) Is actively engaged in the insurance business as a producer and who
20	represents or operates through a licensed Louisiana insurer.

19	education credits shall not exceed four hours.
20	K. The commissioner shall grant twenty-four continuing education credits
21	to a licensed producer who is a member of the legislature while that person is serving
22	a term in the legislature.
23	L. Beginning with license renewals effective in 2015, title insurance
24	producers licensed pursuant to Subpart R of Part 1 of Chapter 2 of this Title, R.S.
25	22:511 et seq., shall complete twelve hours of approved instruction or verifiable
26	approved self-study prior to the renewal of the license with at least two hours
27	dedicated to matters related to state and federal consumer finance protection laws.

M. Any property and casualty <u>insurance</u> producer, upon receiving his initial license, shall complete three hours of approved instruction dedicated to flood insurance on his first license renewal when continuing education is required.

Huval HB No. 721

Abstract: Requires the commissioner of insurance to provide 24 continuing education credits to licensed producers during a term in the legislature.

<u>Present law</u> provides that the continuing education requirements do not apply to any person who is a member of the legislature while serving his term.

<u>Proposed law</u> requires that the commissioner grant 24 continuing education credits to licensed producers serving a term in the legislature.

<u>Proposed law</u> authorizes the commissioner to grant continuing education credits to licensed producers who participate in qualified graduate-level national designation programs or are active participants in a state or national insurance association.
