Provides relative to authorized payroll withholdings for public employees. (8/1/14)

Current law provides for the labor policy when a transit authority acquires or operates a transportation facility and allows that employees of the facility may authorize deductions of wages and salaries for labor union dues, contributions to any health and welfare plan or pension/retirement plan. Proposed legislation removes payment of union dues, fees or assessments as an authorized deduction. Effective August 1, 2014.
