Requires non-governmental entities to submit additional information for line item appropriation requests.

Present law requires non-governmental entities requesting funding from the state through the General Appropriation Bill, Capital Outlay Bill or any supplemental appropriation bill to transmit certain information relative to such proposed funding on a form via the internet. Information required for submission includes but is not limited to the entity's full legal name, amount of proposed funding, comprehensive budget showing all anticipated uses of the proposed monies, entity's public purpose sought to be achieved, certification that the entity has no outstanding audit issues or findings, and the proposed length of time the entity needs to accomplish the stated purpose. Proposed law provides for additional information for submission which requires non-governmental entities to certify that the entity will conduct a public meeting which is advertised no less than 24 hours prior to the start of such meeting to discuss the expenditures of the appropriated funds; make public any records related to the expenditures of the appropriated funds; and agrees to any audits regarding the expenditures of the appropriated funds.
