31 (b) The methodology of distribution shall be as follows:

32 (i) Eighty percent of funds distributed shall be based on degree and certificate
33 production in fields required for Four and Five STAR Jobs, or its successor, as defined by
34 the Louisiana Workforce Commission and weighted by cost and a prioritization of high
35 demand degree and certificate production based on data provided by the Department of
36 Economic Development and the Louisiana Workforce Commission.

37 (ii) Twenty percent of funds distributed shall be based on federally funded research
38 expenditures as defined by the National Science Foundation.

1 (3) The WISE Council shall prepare a statewide workforce demand and gap analysis
2 which shall include:"
