AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2014-3 2015 to be used to pay the consent judgment in the suit entitled "Gayla Bliss, 4 individually and on behalf of the Estate of Lillian Christensen v. Michael Gesling, 5 Lambourne Environmental Diving Service, LLC, Hammerberg Insurance Services, 6 Inc. (D/B/A First Iowa Insurance Agency, Inc.) and State of Louisiana, through the 7 Department of Transportation and Development"; and to provide for related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. The sum of Fifteen Thousand and No/100 (\$15,000.00) Dollars is hereby 10 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2014-2015 to 11 be used to pay the consent judgment in the suit entitled "Gayla Bliss, individually and on 12 behalf of the Estate of Lillian Christensen v. Michael Gesling, Lambourne Environmental 13 Diving Service, LLC, Hammerberg Insurance Services, Inc. (D/B/A First Iowa Insurance 14 Agency, Inc.) and State of Louisiana, through the Department of Transportation and 15 Development", bearing Number 122926 "G" on the docket of the Sixteenth Judicial District 16 Court, parish of St. Mary, state of Louisiana. 17 Section 2. This Act shall become effective on July 1, 2014; if vetoed by the governor 18 and subsequently approved by the legislature, this Act shall become effective on July 1, 19 2014, or on the day following such approval by the legislature, whichever is later.
