WORKERS' COMPENSATION. Exempts certain home improvement contractors who have no employees from the requirements of workers' compensation. (8/1/14)

AN ACT

2	To amend and reenact R.S. 37:2175.2(C) and to enact R.S. 23:1064, relative to workers'
3	compensation; to provide for certain home improvement contractors; to provide for
4	certain exemptions from the requirements of workers' compensation coverage; to
5	provide for remedies in tort; to provide reservation of certain rights; to provide for
6	forms; to provide for affidavits; to provide for permitting; and to provide for related
7	matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 23:1064 is hereby enacted to read as follows:
10	§1064. Home improvement contractors with no employees; exemption from
11	<u>coverage</u>
12	A.(1) The provisions of this Chapter shall not apply to any home
13	improvement contractor who is licensed pursuant to the provisions of R.S.
14	37:2175.2 and who meets all of the following criteria:
15	(a) Has no employees, no independent contractors, and no
16	subcontractors.
17	(b) Is not an officer or principal of any corporation, or a member or

manager of any limited liability company, or a partner of any partnership or a

2	principal of any firm engaged in the principal business of contracting
3	operations who has employees, independent contractors, or subcontractors.
4	(c) The licensed home improvement contractor has chosen to be exempt
5	from coverage pursuant to this Chapter.
6	(2)(a) Any home improvement contractor who avails himself of the
7	provisions of this Section, who would otherwise be immune from a tort liability
8	claim based upon the exclusive remedies provided for in this Chapter, thereby
9	waives any defense or immunity against any claim in tort which would
10	otherwise be subject to the provisions of this Chapter.
11	(b) Any person who would otherwise be covered under the provisions
12	of this Chapter is hereby authorized to pursue any and all claims against the
13	licensed home improvement contractor in tort where such claims would
14	otherwise be subject to the exclusive remedies provided pursuant to the
15	provisions of this Chapter.
16	B.(1) The provisions of Subsection A of this Section shall not exempt or
17	in any way apply to subcontractors or employees of any person, firm,
18	partnership, or corporation engaged within a project under a principal
19	contractor.
20	(2) The provisions of this Section shall require a Home Improvement
21	Contractors' Coverage Exemption form to be completed and submitted to the
22	Louisiana State Licensing Board for Contractors upon application for licensing.
23	(3) An affidavit reflecting the exemption from coverage shall be
24	completed upon the application for any building permit and submitted to the
25	local permits office, with a copy submitted to the Louisiana State Licensing
26	Board for Contractors, before receiving a local building permit.
27	Section 2. R.S. 37:2175.2(C) is hereby amended and reenacted to read as follows:
28	§2175.2. Home improvement contracting; registration required

C. The applicant shall furnish the board proof of general liability insurance 2 in a minimum amount of one hundred thousand dollars, proof of workers' compensation insurance coverage in compliance with Title 23 of the Louisiana 3 **Revised Statutes of 1950**, and proof of registration with the Department of Revenue 5 by providing a certificate of resident/nonresident status. 6

Proposed law provides that a home improvement contractor who is licensed pursuant to the provisions of R.S. 37:2175.2 and who meets all of the following criteria shall be exempt from the requirements of workers' compensation coverage:

- Have no employees, no independent contractors, and no subcontractors. (1)
- (2) Is not an officer or principal of any corporation, or a member or manager of any limited liability company, or a partner of any partnership or a principal of any firm engaged in the principal business of contracting operations who has employees, independent contractors, or subcontractors.
- (3) The licensed home improvement contractor has chosen to be exempt from workers' compensation coverage.

Proposed law provides that any home improvement contractor who avails himself of proposed law, who would otherwise be immune from a tort liability claim based upon the exclusive remedies provided for in workers' compensation, thereby waives any defense or immunity against any claim in tort which would otherwise be subject to the provisions of exclusive remedy in workers' compensation.

Proposed law provides that any person, who would otherwise be limited to the provisions of workers' compensation coverage, is authorized to pursue any and all claims against the licensed home improvement contractor in tort where such claims would otherwise be subject to the exclusive remedies of workers' compensation.

<u>Proposed law</u> provides that the provisions of <u>proposed law</u> shall not exempt or in any way apply to subcontractors or employees of any person, firm, partnership, or corporations engaged within a project under a principal contractor.

<u>Proposed law</u> provides that the provisions of <u>proposed law</u> shall require a Home Improvement Contractors' Coverage Exemption form to be completed, and submitted to the Louisiana State Licensing Board for Contractors upon application for licensing.

<u>Proposed law</u> provides that an affidavit reflecting the exemption from coverage shall be completed upon the application for any building permit and submitted to the local permits office, with a copy submitted to the Louisiana State Licensing Board for Contractors, before receiving a local building permit.
