OFFICIAL JOURNALS: Provides relative to the qualification of a newspaper to publish official proceedings, legal notices, or advertisements in Orleans or Jefferson Parish

1	AN ACT
2	To amend and reenact R.S. 43:142(B), 171(B), 200(3), and 201(D), to enact R.S. 43:202(D),
3	and to repeal R.S. 43:201(E), relative to the publication of official proceedings, legal
4	notices, and advertisements in Jefferson and Orleans parishes; to provide relative to
5	qualifications of newspapers for such publication; to provide for definitions; to
6	provide for an effective date; and to provide for related matters.
7	Notice of intention to introduce this Act has been published
8	as provided by Article III, Section 13 of the Constitution of
9	Louisiana.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 43:142(B), 171(B), 200(3), and 201(D) are hereby amended and
12	reenacted and R.S. 43:202(D) is hereby enacted to read as follows:
13	§142. Qualifications of newspaper
14	* * *
15	B. The provisions of this Section relating to the five-year requirement shall
16	not contravene any contract existing between any governing body and a newspaper
17	on and prior to May 11, 1970; nor shall the five-year requirement herein be applied
18	in assessing the qualifications of a newspaper which was in existence on May 11,
19	1970; nor shall any provision of this Chapter prohibit a publication from becoming

21	As used in this Chapter, the following terms shall have the meanings ascribed
22	to them in this Section:

24	(3)(a) "Newspaper" means a publication that during each year of the five
25	year period prior to the first publication of any legal or official notice therein:
26	(a)(i) Has been published at regular intervals of not less than weekly.
27	(b)(ii) Has been originated and published for the dissemination of current
28	news and intelligence of varied, broad, and general public interest, including regular
29	news coverage of local public meetings and events, and is not devoted to the interests

1	of, or published for the entertainment or instruction of, or has a circulation restricted
2	to, any particular sect, denomination, labor or fraternal organization, or other special
3	group or class of citizens.
4	(c)(iii) Has not been published primarily for advertising purposes and has not
5	contained more than seventy-five percent advertising in more than one-half of its
6	issues, excluding separate advertising supplements inserted into but separately
7	identifiable from any regular issue or issues.
8	(d)(iv) Has maintained a general paid circulation to bona fide paying
9	subscribers within the area the publication is required.
10	(b) For purposes of qualifications for publishing official proceedings, legal
11	notices, or advertisements in the parishes of Jefferson and Orleans, the provisions of
12	this Paragraph relating to a five-year requirement shall not apply to a daily
13	newspaper with a general paid circulation when such newspaper has maintained a
14	public business office in Orleans Parish for eight consecutive months prior to
15	January 1, 2014.

17	§201. Judicial advertisements and legal notices; parishes outside parish of Orleans
18	* * *
19	D.(1) In Jefferson Parish, no provision of this Chapter shall prohibit a
20	weekly publication being selected to publish judicial advertisements and legal
21	notices when if the publication has maintained a public business office for at least
22	five consecutive months in the parish prior to June 1, 2006, and maintained a total
23	circulation of at least twenty-five thousand for at least three consecutive years
24	immediately prior to being selected.
25	E.(2) Notwithstanding any provision of this Section, in Jefferson Parish a
26	daily newspaper with a general paid circulation may be selected to publish judicial
27	advertisements and legal notices if such newspaper has maintained a public business
28	office in Orleans Parish for eight consecutive months prior to January 1, 2014.

1	(3) In Jefferson Parish, the total circulation of every publication or
2	newspaper shall be proved not less than annually by an experienced publication
3	auditing firm prior to the selection of the publication or newspaper under this
4	Section. The audit shall reflect the circulation of the publication or newspaper by
5	parish, and shall be submitted as an attachment to any proposal by a publication or
6	newspaper to publish judicial advertisements and legal notices in Jefferson Parish.

8	§202. Judicial advertisements in parish of Orleans
9	* * *
10	D. Notwithstanding any provision of this Section, in Orleans Parish a daily
11	newspaper with a general paid circulation may be selected to publish judicial
12	advertisements and legal notices if such newspaper has maintained a public business
13	office in Orleans Parish for eight consecutive months prior to January 1, 2014.
14	Section 2. R.S. 43:201(E) is hereby repealed in its entirety.
15	Section 3. This Act shall become effective upon signature by the governor or, if not
16	signed by the governor, upon expiration of the time for bills to become law without signature
17	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
18	vetoed by the governor and subsequently approved by the legislature, this Act shall become
19	effective on the day following such approval.

Abstract: Authorizes a newspaper with general paid circulation and a public business office in Orleans Parish to qualify to publish legal notices and advertisements in Jefferson and Orleans parishes and further authorizes any publication that qualifies to publish such notices and advertisements to be selected as the official journal of a political subdivision in Jefferson or Orleans Parish.

Judicial Advertisements and Legal Notices

<u>Present law</u> (R.S. 43:200, et seq.) requires the selection of newspaper in each parish to run judicial advertisements and legal notices. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> defines "newspaper" for purposes of such laws as a publication that during each year of the five-year period prior to its selection meets all of the following criteria:

- (1) Has been published at regular intervals of not less than weekly.
- (2) Originated and was published for the purpose of delivering news of general public interest and is not devoted to the interests or entertainment of any one particular group or class.
- (3) In more than half of its issues, contained less than 75% advertising.
- (4) Maintained a general paid circulation to paying subscribers within the publication area required.

<u>Proposed law</u> provides that, for purposes of qualifications for publishing official proceedings, legal notices, or advertisements in the parishes of Jefferson and Orleans, the five-year requirement in <u>present law</u> shall not apply to a daily newspaper with a general paid circulation if such newspaper has maintained a public business office in Orleans Parish for eight consecutive months prior to Jan. 1, 2014.

<u>Present law</u> provides that the definition of "newspaper" applies to all parishes. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> relative to all parishes except Orleans (R.S. 43:201) provides that only a newspaper that meets the following criteria may be selected to run judicial advertisements and legal notices:

- (1) Must have been published in an office physically located in the parish for at least five years prior to its selection.
- (2) During that five-year period, may not have missed three or more consecutive issues unless caused by fire, flood, strike, or natural disaster.
- (3) Must have maintained a general paid circulation in the parish for five consecutive years prior to the selection.
- (4) Must have possessed a valid periodical permit from the U.S. Postal Service for a period of five consecutive years prior to selection.

<u>Present law</u> provides an exception for Jefferson Parish for a weekly publication when such publication has maintained a public business office in the parish for at least five consecutive months prior to June 1, 2006, and maintained a total circulation of at least 25,000 for three consecutive years immediately prior to selection. <u>Proposed law</u> retains <u>present law</u>.

<u>Proposed law</u> provides an additional exception to <u>present law</u> for Jefferson Parish and authorizes the selection of a daily newspaper with a general paid circulation to run judicial advertisements and legal notices in such parish if such newspaper has maintained a public business office in Orleans Parish for eight consecutive months prior to Jan. 1, 2014.

<u>Present law</u> relative to Orleans Parish (R.S. 43:202) provides that only a newspaper that meets the following criteria may be selected:

- (1) Must be published in an office physically located in Orleans Parish.
- (2) Must be published in English.
- (3) Must have been published as a daily paper for at least five years prior to selection.

(4) Must have possessed a valid periodical permit from the U.S. Postal Service for a period of five consecutive years prior to selection.

<u>Proposed law</u> provides an exception to <u>present law</u> and authorizes the selection of a daily newspaper with a general paid circulation to run judicial advertisements and legal notices in Orleans Parish if such newspaper has maintained a public business office in such parish for eight consecutive months prior to Jan. 1, 2014.

Selection of Official Journal

<u>Present law</u> establishes criteria that a newspaper must meet in order to be eligible to be selected as the official journal of a political subdivision.

<u>Present law</u> defines "newspaper" for the purposes of selection of an official journal the same way the term is defined for selection of judicial advertisements and legal notices. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> requires that only a newspaper that meets the following criteria may be selected as an official journal by a political subdivision:

- (1) Must have been published in an office physically located in the political subdivision for at least five years prior to its selection.
- (2) During that five-year period, may not have missed three or more consecutive issues unless caused by fire, flood, strike, or natural disaster.
- (3) Must have maintained a general paid circulation in the political subdivision for five consecutive years prior to the selection.
- (4) Must have possessed a valid periodical permit from the U.S. Postal Service for a period of five consecutive years prior to selection.

<u>Present law</u> further provides exceptions to these requirements. Generally, in Jefferson and Orleans parishes, authorizes the selection of a publication as the official journal if the publication has published official proceedings of a political subdivision in such parish within one year prior to June 1, 1986.

<u>Proposed law</u> retains <u>present law</u> and adds additional exceptions. Authorizes the selection of a publication as the official journal of any political subdivision in Jefferson or Orleans Parish if such publication is qualified to publish judicial advertisements and legal notices in Jefferson or Orleans Parish.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Amends R.S. 43:142(B), 171(B), 200(3), and 201(D); Adds R.S. 43:202(D); Repeals R.S. 43:201(E))

Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Municipal, Parochial and</u> <u>Cultural Affairs</u> to the <u>original</u> bill.

- 1. Specifies that the <u>proposed law</u> exception to the five-year requirement applies for purposes of qualifications for publishing official proceedings, legal notices, or advertisements only in the parishes of Jefferson and Orleans.
- 2. Adds provision that makes bill effective upon signature of governor or lapse of time for gubernatorial action.
