| 14 | Louisiana is lower than the national average; and |
| 15 | WHEREAS, in Louisiana this year, an estimated three thousand six hundred thirty |
| 16 | new cases of breast cancer will be diagnosed among women, and six hundred fifty Louisiana |
| 17 | women will die of the disease, many of them facing a late-stage diagnosis involving fewer |
| 18 | treatment options and lower chances of survival; and |
