COMMENDATIONS. Commends the Southeastern Louisiana University men's indoor track and field team upon earning the 2014 Southland Conference Title and Coach Sean Brady on being named the Southland Conference Men's Indoor Coach of the Year.

1 A CONCURRENT RESOLUTION

2 To commend the Southeastern Louisiana University men's indoor track and field team upon
3 earning the 2014 Southland Conference Title and to commend Head Coach Sean
4 Brady on being named the 2014 Southland Conference Men's Indoor Coach of the
5 Year.

6 WHEREAS, the Southeastern Louisiana University men's track and field teams
7 concluded the 2014 Southland Conference Indoor Track and Field Championships at the
8 Birmingham CrossPlex as conference champions; and

9 WHEREAS, the members of the track and field teams showed great sportsmanship
10 and dedication resulting in ultimate success; and

11 WHEREAS, each member is deserving of this great honor as the teams remained
12 disciplined and proudly represented Southeastern Louisiana University; and

13 WHEREAS, seniors Brandon Daniels posted a time of 6.82 seconds in the men's 60-
14 meter dash, earning second place; Tarvoris Mack placed fifth in the men's heptathlon; and
15 T.J. Herbert posted a second-place time of 21.56 seconds in the men's 200-meter dash and
16 also earned fifth place in the men's 60-meter dash with 6.84 seconds; and

17 WHEREAS, after leading the Lions to their first indoor title in history, Head Coach
18 Sean Brady, earned the title of 2014 Men's Indoor Coach of the Year; and

1 WHEREAS, this award adds to his previous accolades of being named South Central
2 Region Co-Men's Head Coach of the Year by the United States Track and Field and Cross
3 Country Coaches Association and Southland Conferences Coach of the Year in 2009; and

4 WHEREAS, senior Jeffrey Milliron joined his coach in the group of men's individual
5 award winners by being named Men's Outstanding Field Performer after winning both the
6 shot put and weight throw; and

7 WHEREAS, Milliron's twenty points scored gave the Lions a big push towards their
8 first indoor title; and

9 WHEREAS, he and his teammate Clarence Robinson, competing in the high jump,
10 were two of the twelve Southeastern athletes named to the 2014 Indoor Track and Field All-
11 Conference Teams which were chosen by a vote of the league's head coaches; and

12 WHEREAS, Southeastern Louisiana University's men's indoor track and field team
13 is a source of pride for the university and the Hammond community.

14 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
15 commend the Southeastern Louisiana University men's indoor track and field team upon
16 earning the 2014 Southland Conference Title and Head Coach Sean Brady on being named
17 the 2014 Southland Conference Men's Indoor Coach of the Year.
