2 On page 1, line 4, between "of" and "student" insert "certain"

4 On page 1, line 5, between "for" and "notification" insert "parental"

6 On page 1, delete line 6, and insert "restrict the use of certain surveys and types of classroom
7 instruction;"

8 AMENDMENT NO. 4

9 On page 1, line 9, change "amended and reenacted" to "enacted"

10 AMENDMENT NO. 5

11 On page 1, line 10, change "**Pubic**" to "**Public**"

12 AMENDMENT NO. 6

13 On page 1, line 11, after "**finds**" delete the rest of the line and delete line 12 and insert the
14 following:

15 **"all of the following:**

16 **(1) That parental involvement is a significant factor in increasing**
17 **student achievement.**

18 **(2) That access to student information encourages greater parental**
19 **involvement."**

20 AMENDMENT NO. 7

21 On page 1, line 14, delete "**lesson plans,**"

22 AMENDMENT NO. 8

23 On page 2, line 4, between **child** and the period "." insert the following:

24 **", except where emergency medical treatment is required. In cases where**
25 **emergency medical treatment is required, the parent shall be notified as soon**
26 **as practicable after the treatment is rendered"**

27 AMENDMENT NO. 9

28 On page 2, line 6, after "**child**" insert "**or by their child**"

29 AMENDMENT NO. 10

30 On page 2, line 7, delete "**before the school allows**" and insert "**if**"

1 AMENDMENT NO. 11

2 On page 2, delete line 8, and insert "**question their child, except in cases where the parent**
3 **has been accused of abusing or neglecting the child.**"

4 AMENDMENT NO. 12

5 On page 2, line 9, change "**before**" to "**if**"

6 AMENDMENT NO. 13

7 On page 2, line 10, between "**campus**" and the period "." insert "**without parental**
8 **permission**"

9 AMENDMENT NO. 14

10 On page 2, line 11, delete "**request and**"

11 AMENDMENT NO. 15

12 On page 2, line 14, delete "**invasive**"

13 AMENDMENT NO. 16

14 On page 2, line 21, delete "**controversial**"

15 AMENDMENT NO. 17

16 On page 2, between lines 21 and 22, insert the following:

17 **"C. Notwithstanding anything to the contrary, a public school shall not**
18 **be required to release any records or information regarding a student's medical**
19 **or health records or mental health counseling records to a parent during the**
20 **pendency of a investigation of child abuse or neglect conducted by any law**
21 **enforcement agency or the Department of Children and Family Services where**
22 **the parent is the target of the investigation, unless the parent has obtained a**
23 **court order.**"
