**Purpose of Bill:** This bill would allow the Louisiana Real Estate Appraisers Board to charge a new Processing Fee of \$25 and increase the existing Temporary Registration Fee from \$50 to \$150.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this bill.

An official with the Louisiana Real Estate Appraisers Board indicated that the Board would not incur any additional expenditures to collect the new revenues provided by this bill.

## **REVENUE EXPLANATION**

This bill may increase the Agency Self-Generated revenues of the Louisiana Real Estate Appraisers Board by \$36,250 annually.

An official with the Louisiana Real Estate Appraisers Board indicated that the fee changes provided by this bill may increase Board revenue by \$36,250 annually (\$125 in fee increases x 290 temporary license permits issued annually).
