FISCAL CONTROLS EG +\$195,000 GF EX See Note Establishes certain requirements regarding state contracts

Proposed bill requires that prior to any contracting entity entering into a contract with a state agency, the contracting entity shall submit various information and documents to the commissioner of administration. Proposed bill provides that a state agency contracting with a contracting entity shall certify that the contracting entity is not on the noncompliance list posted on the website of the legislative auditor at the time the contract is executed. Proposed bill provides that the certification shall be submitted to the commissioner of administration and posted on website no later than 3 business days after the contract is executed. Proposed legislation provides that all submissions of information required of contracting entities shall be made in an electronic format designed by the commissioner of administration. Proposed legislation provides that the commissioner of administration shall maintain information on the website and shall provide for the ability for the public to easily obtain information regarding each contracting entity, including links to any relevant contract information maintained by the commissioner of administration.

## **EXPENDITURE EXPLANATION**

This bill will result in an increase in state expenditures to the DOA in the anticipated amount of \$195,000 in FY 15 of which \$9,000 will be recurring expenditures in subsequent fiscal years and \$156,000 will be one time start up costs. This legislation requires the DOA to post a number of documents on its website and will necessitate the creation of web interfaces with the Legislative Auditor and state agencies, which will require the utilization of a vendor. According to the DOA, all of the necessary information would be stored in the current LaGOV System, which will require one-time application development costs of approximately \$156,000, the purchase of 2 servers at a cost of \$30,000 and \$9,000 of annual maintenance costs associated with the purchase of 2 servers.

According to the DOA, the tasks associated with the one time set up costs (\$156,000) include: expanding the vendor registration portal, adding a new screen to capture the additional information required by this bill, adding a table to hold the additional data, creation of a link to upload the required documents required in this bill, create a state agency portal to allow agencies to view data and certify compliance, creation of a public report with contact information as provided by this bill, creation of an interface with the Legislative Auditor and the creation of a reporting mechanism for state agencies and the purchase of 2 servers.

The annual \$9,000 maintenance costs is based upon the attachment size expectation of the documents to be received by the DOA. To the extent the document size is smaller than the DOA estimate, the annual maintenance costs would be reduced.

There is no anticipated direct material effect on governmental expenditures of the legislative auditor's office as a result of this measure.
