MOTOR VEHICLES: Provides relative to military honor license plates for service during the Cold War

AN ACT

2 To enact R.S. 47:490.26, relative to military honor license plates; to provide for the 3 establishment of a military honor license plate for military service during the Cold 4 War; to require the secretary to promulgate rules and regulations relative to the 5 creation and implementation of this military honor license plate; to provide for the 6 creation, issuance, and design of such plates; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 47:490.26 is hereby enacted to read as follows: 9 §490.26. Military honor license plates; "Cold War Veteran" A. The secretary of the Department of Public Safety and Corrections shall 10 11 establish a military honor license plate to be known as the "Cold War Veteran" plate. 12 B. Upon application of a person showing reasonable proof of honorable 13 service in the Armed Forces of the United States for no less than two years of active 14 duty during the period September 2, 1945, to December 26, 1991, the secretary of the Department of Public Safety and Corrections shall issue a military honor license 15 16 plate to be used in lieu of a regular motor vehicle registration plate. shall be restricted to use on passenger cars, pickup trucks, recreational vehicle
motorcycles, and vans. The military honor license plate shall be known as the "Co
War Veteran" license plate and shall bear a likeness of the Cold War Victory Med
centered on the left side of the license plate and the words "COLD WA
VETERAN" centered on the bottom of the plate. The colors of the plate shall be re-

C. The fee for the license plate shall be the standard motor vehic
registration license fee provided for in R.S. 47:463. In addition to the standard f

assessed and retained by the department to offset a portion of the administrati
costs.
D. The secretary shall adopt rules and regulations to implement to
provisions of this Section, including but not limited to rules governing the transf
of license plates from one vehicle to another and the disposition of such licen
plates.
E.(1) Any applicant who qualifies for the military honor license pla
authorized by this Section may be issued a plate for each vehicle registered in t
applicant's name.
(2) Except as otherwise provided in this Paragraph, each military hon
license plate issued pursuant to this Section shall be returned to the secretary upon
the death of the person to whom the plate was issued. A surviving spouse of
person to whom a license plate was issued pursuant to this Section may retain
license plate issued pursuant to this Section, provided the surviving spouse has n
remarried and provided the surviving spouse applies to the secretary for a transf
of the license plate to the surviving spouse. A military honor license plate

Lorusso HB No. 1150

Abstract: Creates a "COLD WAR VETERAN" military honor license plate.

<u>Proposed law</u> provides for the design and issuance of the "COLD WAR VETERAN" license plate. Specifies that in order for the secretary to issue the license plate, a person must show reasonable proof of honorable service in the armed forces for no less than two years of active duty during the period of Sept. 2, 1945, to Dec. 26, 1991.

<u>Proposed law</u> provides that the license plate shall be restricted to use on passenger cars, pickup trucks, recreational vehicles, motorcycles, and vans. The plate shall bear a likeness of the Cold War Victory Medal, centered on the left side of the plate and the words "COLD WAR VETERAN" centered on the bottom of the plate. The plate shall be red, white, and blue.

<u>Proposed law</u> provides that the fee for such plate shall be the standard motor vehicle registration license fee. Provides for an additional handling fee of \$3.50 to be retained by the department.

<u>Proposed law</u> provides that the secretary shall adopt rules and regulations to implement the plate.

<u>Proposed law</u> provides that any applicant who qualifies for the plate may be issued a plate for each vehicle registered in the applicant's name. Each plate shall be returned to the secretary upon the death of the person to whom the plate was issued, but a surviving spouse of a person to whom the plate was issued may retain the plate provided he or she has not remarried and provided he or she applies to the secretary for a transfer of the plate. The plate shall be returned to the secretary upon the death or remarriage of the surviving spouse.
