3 to the LSU Health Sciences Center Health Care Services for the University Medical 4 Center (Orleans) project in House Bill No. 2 of the 2014 Regular Legislative Session 5 and previous capital outlay Acts to be used to pay and satisfy the judgments for just 6 compensation related to the expropriation of property in accordance with Article I, 7 Section 4 of the Louisiana Constitution of 1974, in the suit entitled "Board of 8 Supervisors of Louisiana State University and Agricultural and Mechanical College 9 v. 1732 Canal Street, LLC, et al"; to provide for costs; to provide for attorney fees; 10 to provide for interest; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. The sum of Five Million Sixty-Six Thousand Six Hundred Forty and No/100 (\$5,066,640.00) Dollars (awarded in the judgment dated May 10, 2012), plus interest from October 18, 2010 until paid, plus costs in the amount of Three Hundred Thousand Twenty-Four and 23/100 (\$300,024.23) Dollars (awarded in the judgment dated April 29, 2013), plus interest from April 29, 2013, plus attorney fees of eighteen percent (18%) of the additional just compensation plus interest awarded in the judgment dated May 10, 2012; plus additional costs and attorney fees for post-trial work in the amount of One Hundred Thirty-Five Thousand and No/100 (\$135,000.00) Dollars (awarded in the judgment dated April 2,

1 2014); said interest amounts to be calculated pursuant to R.S. 19:155; are hereby 2 appropriated, allocated or otherwise made available out of the moneys appropriated and 3 allocated to the LSU Health Sciences Center Health Care Services for the University 4 Medical Center (Orleans) project (the "project") in House Bill No. 2 of the 2014 Regular 5 Legislative Session for Fiscal Year 2014-2015 or previous Acts of the Legislature, to be used 6 to pay and satisfy the judgments related to the expropriation of property related to said 7 project and in accordance with Article I, Section 4 of the Louisiana Constitution of 1974, in 8 the suit entitled "Board of Supervisors of Louisiana State University and Agricultural and 9 Mechanical College v. 1732 Canal Street, LLC, et al", bearing Number 10-10488, Section 10 "8", Division "N", on the docket of the Civil District Court, parish of Orleans, state of Louisiana and No. 2012-CA-1370 on the docket of the Fourth Circuit Court of Appeal, state 11 12 of Louisiana. 13 Section 2. The judgments provided for in Section 1 hereof shall be deemed to have 14 been paid on the effective date of this Act and legal interest shall cease to run as of that date. 15 Section 3. This Act shall become effective on July 1, 2014; if vetoed by the governor 16 and subsequently approved by the legislature, this Act shall become effective on July 1, 17 2014, or on the day following such approval by the legislature, whichever is later.

I, Sec. 4 of the La. Constitution of 1974, in the suit entitled "Bd. of Supervisors of LSU A&M College v. 1732 Canal St., LLC, et al", bearing No. 10-10488, Sec. "8", Div. "N", on the docket of the Civil District Court, parish of Orleans, state of La. and No. 2012-CA-1370 on the docket of the 4th Circuit Court of Appeal, state of La.
