6	Be it enacted by the Legislature of Louisiana:
7	Section 1. Subpart L of Part III of Chapter 17 of Title 39 of the Louisiana Revised
8	Statutes of 1950, comprised of R.S. 39:1647 is hereby enacted to read as follows:
9	SUBPART L. ACQUISITION OF SEATS IN PUBLIC SEATING AREAS
0	OF STATE BUILDINGS
1	§1647. Procurement of seats in public seating areas of state buildings; requirements
12	for seats with arms; exceptions
13	A. Except as provided in Subsection B of this Section, when the procurement
14	officer of a using agency covered by this Chapter makes any purchase of seats for
15	public seating areas following the renovation or construction of a state building, no
16	fewer than five percent of the total seats purchased shall have arms.
17	B. This Section shall not apply to any of the following:
18	(1) Seating located in instructional spaces at public educational institutions.
19	(2) Seating areas located in stadiums, coliseums, arenas, or similar buildings
20	used as sport or entertainment venues.
21	(3) Cafeterias or other food service areas.

Abstract: Requires no fewer than 5% of the total seats purchased for public seating areas following the renovation or construction of a state building shall have arms.

<u>Present law</u> establishes the Louisiana Procurement Code relative to purchasing by certain state agencies.

<u>Proposed law</u> requires that when an agency covered by <u>present law</u> makes any purchase of seats for public seating areas of state buildings following the renovation or construction of a state building, no fewer than 5% of the total seats purchased have arms.

<u>Proposed law</u> further provides that the seat purchasing requirement shall not apply to the following:

- (1) Seating located in instructional spaces at public educational institutions.
- (2) Seating areas located in stadiums, coliseums, arenas, or similar buildings used as sport or entertainment venues.
- (3) Cafeterias or other food service areas.
