Proposed law provides that third-party training may be provided by a Louisiana college or university in Incumbent Worker Training Program. Proposed law provides that a Louisiana college or university may subcontract with an out-of-state college or university to provide third-party training so long as the training takes place on the campus of a Louisiana college/university or a job site. Proposed law provides a process for determining whether third-party training exists on a Louisiana college or university. Proposed law becomes effect 08/01/2014.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. This proposed legislation provides that a Louisiana college or university may become a third-party training provider in the Incumbent Worker Training Program. Once a Louisiana college or university becomes a third-party training provider, the proposed law allows the Louisiana college or university to subcontract with an out-of-state state college or university to provide third-party training as long as the training takes place on the campus of the Louisiana college or university or a job site. There is no impact on the Incumbent Worker Training Program as a result of this measure. Presently, the cost of training in the Incumbent Worker Training Program is \$25.2 M and is anticipated to remain the same as a result of this measure.

REVENUE EXPLANATION

The proposed legislation may increase revenues by an indeterminable amount to a Louisiana college or university that becomes a third-party training provider in the Incumbent Worker Training Program.
