1 AMENDMENT NO. 1

2 On page 1, line 2, between "R.S. 38:326.3" and the comma "," insert "and 326.4"

3 AMENDMENT NO. 2

4 On page 1, line 6, between "authority;" and "and" insert "to provide for an executive director  
5 and an assistant executive director of the Lafourche Basin Levee District;"

6 AMENDMENT NO. 3

7 On page 1, line 9, change "is" to "and 326.4 are"

8 AMENDMENT NO. 4

9 On page 1, line 15, change "**shall**" to "**may**"

10 AMENDMENT NO. 5

11 On page 2, line 1, change "**shall**" to "**may**"

12 AMENDMENT NO. 6

13 On page 2, at the end of line 6, add "**The cooperative endeavor agreement shall provide**  
14 **that title to equipment used pursuant to the agreement which is owned by the port or**  
15 **a district shall remain with the port or district.**"

16 AMENDMENT NO. 7

17 On page 2, line 7, between "**C.**" and "**Each**" insert the following:  
18 "**(1) Notwithstanding any law to the contrary, any police officer applicant with**  
19 **at least twenty years of experience as a commissioned law enforcement officer**  
20 **who possesses the qualifications of Paragraph (2) of this Subsection shall be**  
21 **exempt from any test requirement of any applicable civil service law or**  
22 **regulations.**

24 AMENDMENT NO. 8

25 On page 2, line 13, between "**Section**" and "**shall**" insert "**which is a party to a cooperative**  
26 **endeavor agreement described in Subsection B of this Section**"

27 AMENDMENT NO. 9

28 On page 2, line 18, change "**shall**" to "**may**"

29 AMENDMENT NO. 10

30 On page 2, line 21, change "**Subsection C**" to "**Paragraph (C)(2)**"

31 AMENDMENT NO. 11

32 On page 2, delete line 22, and insert "**be exempt from any test requirement of any**  
33 **applicable civil service law or regulation.**"

1 AMENDMENT NO. 12

2 On page 3, after line 3, insert the following:

3 **"§326.4. Lafourche Basin Levee District; executive director; assistant executive**  
4 **director; duties**

5 **A. The positions of executive director and assistant executive director of the**  
6 **board of commissioners of the Lafourche Basin Levee District are hereby**  
7 **created. The executive director and assistant executive director shall be**  
8 **appointed by the board. The executive director, on behalf of and as authorized**  
9 **or directed by the board, shall administer the affairs of the district. The**  
10 **assistant executive director shall assist the executive director in all of his**  
11 **functions and duties as deemed necessary in order that any time, the assistant**  
12 **executive director is able to assume the daily responsibilities of the executive**  
13 **director.**

14 **B. The positions of executive director and assistant executive director shall be**  
15 **filled by the board within six months after this Section becomes effective.**

16 **C. Neither the executive director nor the assistant executive director shall be**  
17 **a member of the board. The executive director and assistant executive director**  
18 **shall each be a full-time unclassified employee of the board who shall be paid**  
19 **compensation in an amount to be determined by the board which shall be**  
20 **comparable to like positions with levee districts throughout the state."**
