SHERIFFS: Provides relative to payment of group insurance premiums for retired sheriffs and deputy sheriffs of the West Baton Rouge Sheriff's Office

AN ACT

2	To enact R.S. 13:5554(G)(3), relative to the payment of group insurance premium costs; to
3	provide for eligibility for payment of such costs for retired sheriffs and retired deputy
4	sheriffs of the West Baton Rouge Parish Sheriff's Office; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 13:5554(G)(3) is hereby enacted to read as follows:
8	§5554. Group insurance; kinds; amounts; subrogation

12	(3) Notwithstanding the provisions of Subsection D of this Section, in the
13	parish of West Baton Rouge, one hundred percent of the premium costs of group
14	hospital, surgical, medical expense and insurance and the first ten thousand dollars
15	of life insurance contracted for under the provisions of this Section shall be paid in
16	full from the sheriff's general fund for any sheriff and full-time deputy sheriff who
17	has retired from the West Baton Rouge Sheriff's Office and who is entitled to receive
18	monthly benefits from the Sheriff's Pension and Relief Fund and who has either of
19	the following:

1 (a) At least twelve years of full-time creditable service with the West Baton 2 Rouge Parish Sheriff's Office and who was hired before June 30, 2008, and is at least 3 fifty-five years of age. 4 (b) At least thirty years of full-time service with the West Baton Rouge 5 Parish Sheriff's Office, regardless of age. (c) The provisions of Paragraph (1) of this Subsection shall apply for any 6 7 sheriff, deputy sheriff, and all persons hired by the West Baton Rouge Parish 8 Sheriff's Office on or after July 1, 2008. 9

Thibaut HB No. 221

Abstract: Provides relative to the payment of group insurance premiums for retired sheriffs and employees hired prior to June 30, 2008, for West Baton Rouge Parish Sheriff's Office.

<u>Present law</u> provides that the premium costs of group hospital, surgical, medical expense, and dental insurance, and the first \$10,000 of life insurance shall be paid in full from the sheriff's general fund for all sheriffs and deputy sheriffs retired with at least 15 years of service who are at least 55 years of age or retired with at least 30 years of service at any age.

<u>Proposed law</u> provides that 100% of the premium costs of group hospital, surgical, medical expense, vision and dental insurance, and life insurance shall be paid by the West Baton Rouge Parish Sheriff's Office for all sheriffs and employees who retire with 12 years of service with the West Baton Rouge Parish Sheriff's Office and who are at least 55 years of age.

<u>Proposed law</u> provides that 100% of the premium costs of group hospital, surgical, medical expense, vision and dental insurance, and life insurance shall be paid by the West Baton Rouge Parish Sheriff's Office for all sheriffs and employees who retire with 30 years or more of service with the West Baton Rouge Parish Sheriff's Office, regardless of age.

<u>Proposed law</u> applies to persons hired by the West Baton Rouge Parish Sheriff's Office before June 30, 2008. Premium costs for persons hired on or after July 1, 2008, shall be paid pursuant to <u>present law</u>.
