3 insert "R.S. 26:2(9), 3(A)(2), 241(15),"

9 entirety and insert "to provide relative to the definition of adulterated foods; to provide for
10 definitions; to prohibit certain acts on licensed premises; to prohibit the sale of certain types
11 of ice cream to persons under the legal age for purchasing alcoholic beverages; to provide
12 for certain notice requirements; and to provide for related matters."

14 On page 1, line 7, after "Section 1." delete the remainder of the line and insert "R.S. 26:2(9),
15 3(A)(2), 241(15), and 421(A)(2) are hereby amended and reenacted and R.S. 26:90(A)(17)

17 AMENDMENT NO. 5

18 On page 1, between lines 8 and 9, insert the following:

20 For purposes of this Chapter, the following terms have the respective
21 meanings ascribed to them in this Section, unless a different meaning clearly appears
22 from the context:

24 (9) "Liquor retailer" means any dealer, other than a manufacturer or
25 wholesaler, who sells, offers for sale, exposes for sale, or has in his possession for
26 sale or distribution any alcoholic beverages or any adulterated confectionery or ice
27 cream as defined in R.S. 40:607(A) in any quantity.

30 On page 1, between lines 14 and 15, insert the following:

31 §90. Acts prohibited on licensed premises; suspension or revocation of permits

32 A. No person holding a retail dealer's permit and no agent, associate,
33 employee, representative, or servant of any such person shall do or permit any of the
34 following acts to be done on or about the licensed premises:

39 §241. Definitions

1 The following terms have the respective meanings ascribed to them except
2 in those instances where the context indicates a different meaning:

4 (15) "Retail dealer" means every person who offers for sale, exposes for sale,
5 has in his possession for sale or distribution, or sells alcoholic beverages or any
6 adulterated confectionery or ice cream as defined in R.S. 40:607(A) in any quantity
7 to persons other than licensed wholesale or retail dealers.

9 §286. Acts prohibited on licensed premises; suspension or revocation of permits
10 A. No person holding a retail dealer's permit and no servant, agent, or
11 employee of the permittee shall do any of the following acts upon the licensed
12 premises:

14 (17) Sell or serve any confectionery or ice cream product in violation of R.S.
15 40:607(D).

23 On page 2, line 9, after "confectionery" and before "by" and insert "or ice cream"

25 On page 2, line 11, after the period "." delete the remainder of the line and line 12 in its
26 entirety

27 AMENDMENT NO. 11

28 On page 2, after line 13, insert the following:

29 "D. For purposes of this Section:

30 (1) Anyone who sells confectionery or ice cream that contains more than
31 one-half of one percent alcohol rendered unfit for beverage purposes to a person who
32 is under the legal age for purchasing alcoholic beverages shall be fined not more than
33 three hundred dollars or imprisoned for not more than six months, or both.

34 (2) Any confectionery ~~manufactured~~ or ice cream sold or offered for sale in
35 this state that contains more than one-half of one percent alcohol rendered unfit for
36 beverage purposes shall bear a label containing the statement: "Sale of this product
37 to persons under the legal age for purchasing alcoholic beverages is unlawful." A
38 person who violates the provisions of this Paragraph shall be fined not more than
39 three hundred dollars or imprisoned for not more than six months, or both.

40 (3) No confectionery or ice cream containing more than one-half of one
41 percent alcohol rendered unfit for beverage purposes shall be sold or offered for sale
42 in this state unless ~~the product bears a label that meets the requirements of Paragraph~~
43 ~~(2) of this Subsection or~~ a sign containing the statement: "Sale of confectionery or
44 ice cream containing more than one-half of one percent alcohol to persons under the
45 legal age for purchasing alcoholic beverages is unlawful" is displayed at the place
46 where the product is sold or offered for sale. A person who violates the provisions
47 of this Paragraph shall be fined not more than three hundred dollars or imprisoned
48 for not more than six months, or both."
