Changes the date from June 1 of each year to September 1 of each year for information to be supplied to the assessor and legislative auditor by tax recipient agencies in St. Charles Parish. (gov sig)

**Purpose of Bill:** This bill extends the deadline from June 1 to September 1 for taxing authorities within St. Charles Parish to provide information (i.e. tax rate and authorizing ordinances or resolutions) to the assessor and the legislative auditor.

## **EXPENDITURE EXPLANATION**
