CLERKS OF COURT EG NO IMPACT See Note
Provides relative to processing fees associated with reporting requirements for clerks of court

<u>Present law</u> requires that a processing fee of \$5 for the clerk of court and \$5 for the office of judicial administrator for the supreme court, not to exceed \$10 in each suit, be taxed as costs of court in each suit for any information that is required by supreme court rule to be submitted by the clerk of court.

<u>Proposed law</u> deletes this provision of <u>present law</u> that requires that the court cost shall be paid only at the conclusion or dismissal of the suit.
