Provides for settlement practices involving certain claims against nonresident self-insurers and self-insurance plans. (8/1/14)

<u>Proposed law</u> requires nonresident drivers involved in an accident to show proof of coverage as a self-insurer or under a self-insurance plan from his or her state of residence; provides for validity of proof of coverage as a self-insurer or under a self-insurance plan in that the insured agrees to pay the amount of any claim due within 30 days after receipt of satisfactory proof of loss or within 30 days after written agreement of settlement from a third-party claimant; provides that failure to make payment within 30 days shall subject such individuals to a penalty; provides that the self-insurer or self-insurance plan owes a duty of good faith and fair dealing and provides for liability for damages as a result of a breach of good faith; provides for conditions constituting a breach of the insurer's duties under <u>proposed law</u>; and provides that in addition to any special damages entitled to a claimant for breach of imposed duty, the claimant may be awarded penalties in an amount not to exceed two times the damages sustained or \$5,000, whichever is greater. Proposed law is effective August 1, 2014.
