SENATE RESOLUTION NO. 97

CONDOLENCES. Extends condolences upon the death of U.S. Marine Corps Gunnery Sergeant Gregory J. Mullins.

1	A RESOLUTION
2	To express the sincere condolences of the Senate of the Legislature of Louisiana to the
3	family of United States Marine Corps Gunnery Sergeant Gregory Mullins upon his
4	death during a combat training exercise in California.
5	WHEREAS, Gunnery Sergeant Mullins grew up in Bayou L'Ourse, a small town in
6	Assumption Parish where everyone in the community knew each other, worshiped together,
7	and worked along the side of their neighbor; and
8	WHEREAS, Gunnery Sergeant Mullins graduated from Morgan City High School
9	and in March of 2002, he enlisted in the U.S. Marine Corps to fulfill his lifelong goal of
10	becoming a Marine; and
11	WHEREAS, Gunnery Sergeant Mullins had long valued loyalty, courage and
12	integrity, and he worked and trained hard, and made those qualities a part of his life as a
13	dedicated Marine; and
14	WHEREAS, as a highly respected member of the Corps, he chose as his field of
15	expertise the extremely dangerous job of an explosive ordnance disposal technician, and
16	after much training, he became part of an elite team of Marine Corps ordnance experts; and
17	WHEREAS, Gunnery Sergeant Mullins mastered his military duties and
18	responsibilities quickly and was steadily promoted as his leadership skills were recognized

1	by his superior officers; an inspiration to his men, the troops in his unit followed his orders
2	without hesitation; and
3	WHEREAS, Gunnery Sergeant Mullins would be deployed twice to Afghanistan, in
4	2011 and 2012, as a team leader and learned much as he patrolled the often ambushed routes
5	of the deadly war zone in search of much feared improvised explosive devices; and
6	WHEREAS, Gunnery Sergeant Mullins returned to the United States from Operation
7	Enduring Freedom with much combat experience and was chosen to serve as the
8	Noncommissioned Officer-In-Charge assigned to Headquarters and Headquarters Squadron,
9	Marine Corps Air Station, Camp Pendleton; and
10	WHEREAS, on November13, 2013, thirty-one year old Gunnery Sergeant Mullins
11	was one of a group of Marine Corps Explosive Ordnance Disposal technicians sweeping a
12	firing range called the Zulu impact area where munitions such as grenades, mortars, artillery
13	and rockets were used for training Marines in the dangerous art of war; and
14	WHEREAS, during the range maintenance operation to dispose of unexpended
15	ordnance, no live fire of weapons are allowed, but the munitions being collected and secured
16	for disposal can be so unstable that handling them is extremely dangerous, even for the elite
17	and highly trained Marine explosives experts; and
18	WHEREAS, Range NCOIC Gunnery Sergeant Mullins, Staff Sergeant Mathew
19	Marsh, Staff Sergeant Eric Summers, and Sergeant Miguel Ortiz were all mortally wounded
20	when the munitions they were collecting detonated; and
21	WHEREAS, Gunnery Sergeant Mullins awards and decorations include two Navy
22	and Marine Corps Commendations Medals, the deeply respected Combat Action Ribbon,
23	three Marine Corps Good Conduct Medals, the National Defense Service Medal, the
24	Afghanistan Campaign Medal, the Global War on Terrorism Service Medal and the NATO
25	Medal-ISAF Afghanistan.
26	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
27	does hereby extend its deepest and most profound condolences to the family of Gunnery
28	Sergeant Gregory Mullins for the immeasurable loss they have suffered by his death and for
29	the ultimate sacrifice this Marine made.
